MINUTES DISTRICT 11NR BOARD AND STAFF MEETING 20 March 2009 Rohnert Park CA

The meeting was called to order at 1400 by DCO Mike Williams. The Pledge of Allegiance was led by Robert Firehock, DSO-LP. DCO Williams called for a moment of silence for the four California policemen killed in the line of duty, whose funeral is today. DCO Williams introduced the following special guests:

Joyce Bell, DSO-SR called the roll, and DCO Williams declared that a quorum was present. The attendance list is attached to these minutes as Attachment 1.

APPROVAL OF MINUTES:

DCO Williams called for approval of the 17 January 2009 minutes.

<u>Motion</u>: Dick Hoelle, DCDR-7 moved and Charlie Duncan, P-PCA seconded that the minutes be approved as distributed. There being no discussion, the motion was adopted.

DCO Williams called for approval of the 25 February 2009 minutes.

<u>Motion</u>: Dean LaChapelle, DCDR-3 moved and Roger Haynes, DCDR-12 seconded that the minutes be approved as distributed. There being no discussion, the motion was adopted.

DCO REPORT

DCO Williams reported on the items discussed during the 20 February EXCOM meeting in San Diego CA.

COMMENTS - COMO Vic Connell, ARCO-P

COMO Connell stated that we are waiting for the CG Modernization package. When it is implemented, we will look a lot different. At that time we will be aligning more closely with the Coast Guard. We will begin to see the changes later this year. COMO Connell stated that the current economic conditions have placed our country in a "perfect storm" situation for volunteerism. He expressed thanks for all who are volunteering.

COMMENTS - CAPT Mark Rizzo, Chief Director of Auxiliary

CAPT Rizzo stated that he currently wears two hats – RBS as well as Auxiliary Boating Director. CAPT Rizzo reported on the following:

- Sea Cadet Program This program was started in 1982. The Coast Guard has entered into an MOU with the Navy League to revive this program. Our focus will be on-the-water training only, and they want to use the Auxiliary to help the Navy League in providing this OTW training. This MOU is only with the Sea Cadets, so we cannot engage in the same activity with any other groups. Also, it is only for OTW training service.
- TWIC Cards Program The DOD is working on a way to get these cards for some
 Auxiliarists who need the cards for their work with the Coast Guard. They are going to
 do a test with D1, D8W and D14 using a "volunteer card," to see how it works. If it does,
 they will be able to issue TWIC cards for all Auxiliarists who need them. Until then, the
 current password sign-on will still be used.
- CAPT Rizzo described a situation in D13 which could have resulted in the need to salvage an Auxiliary vessel that was under orders. The vessel was saved and didn't need the services, but it raised the question as to whether or not the Coast Guard could fund salvage services for an Auxiliary vessel under orders, if needed. The answer from Legal was that an Auxiliary vessel is a Coast Guard vessel, so they are covered. There is still some conversation among groups as to who will provide the funds. National will figure out a way to do it. It will be funded.
- Some questions have been raised concerning Civil Air Patrol flying for the Coast Guard.
 This is happening; however they will not be flying traditional Auxiliary missions. They will
 be flying for the DOD, on specific classified missions with specific gear, which Auxiliary
 aviation cannot do.
- ICS-210. We are at 90% in the Coast Guard. The deadline for completion of ICS-210 has been extended to 1 April 2010.
- The highest population of boaters is in D11's AOR. CAPT Rizzo expressed appreciation for everything being done to assist the boating public.
- Coast Guard Modernization The major initiative will be to explore how the Coast Guard Auxiliary can better support the Coast Guard not only in RBS and OPS, but in all other areas. There will be a lot of areas where the Auxiliary can offer support.

DCO Williams called for district board reports as follows:

<u>Mary Kirkwood, DCDR-1</u> – Report on file (Attachment B). Kirkwood highlighted the division's upcoming dockwalkers event and OPTREX.

<u>Dean LaChapelle, DCDR-3</u> – Report on file (Attachment B). LaChapelle highlighted the division OPTREX being held the end of April at Lake Shasta. The dockwalkers program begins April 16, with 10 people scheduled to start. Their telephone tree exercise went off well.

<u>Jerry McAlwee, DCDR-4</u> – Report on file (Attachment B). Nothing further to report.

Ray VanCleave, DCDR-5 – Report on file (Attachment B). VanCleave reported that their division OPTREX is 2 May at CG STN Vallejo. OTW patrols are going full speed, and they are supporting STNs Rio Vista, Vallejo and Bodega Bay.

<u>Mark McLaughlin, DCDR-6</u> – Report on file (Attachment B). The division was honored to host, with STN Monterey, ADM Thad Allen, with CAPT Gugg and CDR Davidson, yesterday. ADM Allen discussed the fact that there are changes coming and budgetary issues. However, he said they will no longer "do more with less." The new motto will be "do your best with what you have." The ADM has a face book account and blog.

<u>Dick Hoelle, DCDR-7</u> – Report on file (Attachment B). The division continues to work with Utah State Park Rangers. On April 8-9 we will provide Navigation and SAR training. This training program is headed by Lou Carroll. The division has received a list from Utah State of special events they want assistance with.

Richard Thomas, DCDR-8 – The planned mail-out resulted in mailing 1100 letters, and was completed earlier this week. They have had 15 calls so far, but expect more since the mailing has only been out about 2 days. Flotillas 87 and 88 had their annual corned beef and cabbage feed. They served 54 Coast Guard people. Training classes are going well. Crescent City is working with the local sheriff's department. Mendocino has an Auxiliarist who has qualified as a Coast Guard crewmember. The Humboldt Air Station refueling assistance program is ongoing. The BLM has asked the Auxiliary to participate by patrolling on ATV's. Lake County members are working with lake management in lake shore cleanup.

Monica Eaton, DCDR-10 – Report on file (Attachment B). The division hosted a PA booth and VSC station with Pro Bass Shop. They were situated next to life jackets and were able to assist visitors by showing them how to properly fit life jackets. They have been invited back to help train the store's employees on how to fit life jackets.

<u>Dee Dee Kincade, DCDR-11</u> – Report on file (Attachment B). Division 11 is actually on the water. To date, they have more hours OTW than any other division. The Coast Guard loaned the division 20 MSD900 suits. 22 members became qualified in the dry suits. STN Tahoe is not able to launch their boat because of low water. They need training, so these division members have worked with the Coast Guard to do training of their CG personnel. The tribal people at Lake Pyramid are doing more fishing derbies, so we have been doing more patrols. We are putting pictures and blogs on our web pages.

Roger Haynes, DCDR-12 – Report on file (Attachment B). During the recent disaster drill Haynes used an e-mail notification first; then followed up with phone calls. He discovered that many members had already read the e-mail, so it streamlined the telephone notifications.

<u>Charlie Duncan, P-PCA</u> – Report on file (Attachment B). Duncan reported that there are new personnel at Coast Guard Island, so they are beginning contact with them to see if we can get a new location and plan for the Auxiliary memorial.

<u>Wayne Farnholtz, DCAP-RES</u> – Report on file (Attachment B). Contingency Response Plan – Farnholtz is working on a template for member information which can be used. He will be asking for input from DCDRs on their members. The Gold Side uses the AuxPal system. We

would like to do quarterly drills and communications exercises. We would also like to try some tabletop exercises. Farnholtz has prepared a draft of a disciplinary guideline plan to assist FC's and DCDR's to take care of the flow of information for disciplinary action. He had assistance from Robert Firehock and Robert Liu, district legal in putting together the guideline. It will be distributed following final approval.

Robert Hendry, DCAP-RBS – Report on file (Attachment B). NSBW is May 16-22. All DCDR's have appointed a contact. This should be a good year. The divisions have also provided a contact for America's Waterways Watch program. Tomorrow will be the kick off for AWW. Stop by the MS activity workshop.

Rodney Collins, DCAP-SPT – April is Coast Guard Mutual Assistance Month. Collins is the 2009 campaign head for D11N. ADM Allen has chosen "Looking After Our Own" for this year's theme. This is non-profit charitable, and works from contributions and its own assets. There are no government funds. When you get your packet in the mail, anything would be appreciated – suggest \$3 per Auxiliarist. Collins passed a hat among attendees. At the close of the meeting, Collins reported that \$282.00 was donated.

Angelo Perata, COS – Perata created a "What We Do in the Auxiliary" manual last year. The manual is designed to be updating as needed. New FC's will get a copy of the manual during their training on Sunday. Perata called attention to the life jacket display, which has infomation on how they work and who can wear what. Size life jackets for kids by weight. We will be getting more displays from the CDR Chareonsuphiphat and Paul Newman, RBS Specialist, so they can be displayed throughout the district.

<u>CDR David Chareonsuphiphat, DIRAUX</u> – During NSBW there will be an article about the Auxiliary in the *Yachtsman* magazine. CDR Chareonsuphiphat expressed thanks to the DIRAUX staff for the work they are doing. Thanks to Roger Haynes for helping with museum at the lighthouse on Admiral's residence. CDR Chareonsuphiphat expressed his pride in the accomplishments of the district. "D11 is #1 twice."

<u>Jeff Price, DSO-CM</u> – Report on file (Attachment C). The Coast Guard Sector SF communications station has been loaned to us for the D-Train program, including medical staff. It is set up in the parking lot. Come out and see the station.

We had 6 vessels ready to go in 32 minutes and 10 mobile facilities in 18 minutes. There were various responses on wellness contacts. The drill did turn up some problems, in some divisions more than others, but the purpose of the drill was to discover where the problems are. 26 volunteers are participating in the "loose a ton" campaign.

DETAILS

- 1. Div4 will augment the Port of Redwood city marine area disaster drill on 31 MAR with at least one on-water facility. This is in conjunction with a Port facility and a Police facility from Redwood City.
- 2. Participation in the District Emergency Call Out Drill made use of the Call Tree charts produced by each Flotilla last year. Lessons learned include need to establish periodic schedules for updating these trees as well as providing an instruction set on the back of the Call Tree form. 70% of the membership was contacted within 30min for an average of 30 sec/member once the DCDR was notified by the ASC. The remaining 30% required over 2 hours and was isolated to one Flotilla. Problems are easily corrected.
- 3. SYC hosted the March Div4 Meeting on 25 MAR. Attendance was unusually high on account of Administrative Issues. Requests and procedural protocol reviews with the Chain-of-Leadership have been productive and are in process.
- 4. SBOD activities are scheduled and have been planned using ICS-201 Form as part of Division ICS Training Exercise. Activities will include Safety Patrol and participation in Regatta, AUXCOM Land Mobile Radio Guard, PA Trailer in SYC parking Lot and

- PA/VSC Booth at Launch Ramp.
- 5. Two Division members attended the AUF program brief at CGI. Several coxswains and Crews are prepared to support training requirement and working with District OPS on scheduling protocol.
- 6. Several Division members are continuing to attend Air Squadron Dinners and support ADSO-OP projects for integrating Air and Surface assets in a modernization development for SAR and AWW objectives. Next meeting is 31 MAR.
- 7. NSBW in Div4 will include West Marine VSC Events in San Carlos, Redwood City, and SCC Lakes in addition to news print, radio, and press release efforts in the South Bay area. Committee participants from Flotillas are working best practice Span-of-Control coordination with Division NSBW Chair.
- 8. Consultation with District Legal et al has been initiated to better understand OPSEC and COMSEC policies on various Auxiliary documents including reports, memos, minutes, etc., the DCDR has supplied all Division FC's and appointed SO Staff with encrypted flash drives for storage and maintenance of Aux documents. This affords improved transportability as well as security. Flash Drives provided are 100% waterproof.
- 9. SO-VE has held meeting with SCC Parks to determine protocol for VSC inspection at Lake Launch ramp facilities including Anderson, Coyote, and Calero. This includes identification of inspection areas, updates on Invasive Specie Inspection Process so Auxiliary does not interfere, and VSC schedules to improve awareness and increase inspections for boaters.
- 10. Div4 will hold a Dock Walkers and Marine Safety Forum and has invited Vivian Matuk from Cal Boating to be our guest speaker. Date will soon be released along with locale and we again request input from area Divisions and partners for interest in attending and what desired objectives for MS education are best.
- 11. Most Flotilla websites have maxed out national server and have planned to migrate to District Server.
- 12. For the third year, Div4 supplied judges to the regional Synopsis Science and Technology Fair held in downtown San Jose. Five students will be receiving awards and presentation will be at Great America on the afternoon of March 29. One Academy candidate was identified with referral to USCGA Admissions.
- 13. PE Programs are continuing to create new course schedules and these will soon be printed and distributed to Division PE/PA/VE/PV officers.

Also in attendance were LT Kahle CO Station Monterey and AUXLO BM1 Strickland. An excellent presentation on marine forecasting was given. Of particular interest for the Coast Guard members in attendance was the new grid forecasting system. The marine area is divided into 2 kilometer square grids with a forecast given hourly for each grid. This would allow a coxswain, when creating his DR plot, to have a forecast for the weather to be expected at each waypoint. This would be of tremendous advantage for Station Monterey in planning a SAR mission to, for example, Pt. Sur. The coxswain would know what to expect as far as weather and seas for his journey down, on scene and for the return. The Coast Guard expressed a great desire in utilizing this program and the auxiliary felt that it had done a great service in making it available to them.

Pocket orders, non-reimburseable, will be given by Sector for land patrols and observation missions may be performed as part of multimission sea, air and land mobile patrols. Reports will be gathered through the ADSO-MS each month.

- 3. While there were conflicts with District official availability and the COW dates of five divisions (and one additional potential), at this time there is only one conflict remaining and one potential which has not been scheduled yet.
- 4. Division 8 held their regularly scheduled meeting at a central point in their AOR Garberville, CA. The meeting was well attended and business conducted professionally. Of interest was a featured book entitled "Point Cabrillo Light Station", which was authored by a member of Division 8 (Bruce Rogerson), in commemoration of 100 years of service to the maritime communities on the North Coast of California.
- 5. To complete the Strategic Plan developed by EXCOM, DCAPTs were requested to work with respective DSOs to develop measurable goals for 2009. In my areas, this included AWW implementation, vessel exams, public education graduates, program visitations, public event contacts, fishing vessel exams, ferry and commercial vessels audits and PATONS and bridge surveys. To date, nearly half of goals are proposed with the remainder being completed by March 26. EXCOM will discuss these proposed goals at its D-Train meeting.

Disaster Drill

On March 7, 2009, Sector San Francisco conducted a disaster drill involving Auxiliary members from throughout the District. The scenario was a severe earthquake, with both Station San Francisco and Station Golden Gate damaged, and the Golden Gate and Bay Bridges closed.

Sector made four requests of the Auxiliary:

- 1) That we account for all our members;
- 2) That we supply five vessels, four to provide transportation between Yerba Buena Island and Jack London Square, and one to provide transportation between Station Golden Gate and San Francisco;
- 3) That we supply four Auxiliarists to assist with logistics on Yerba Buena Island;
- 4) That we place all land-mobile units on standby to listen for any distress calls that the Coast Guard might not hear.

Within 18 minutes of the request, all available land-mobile units (plus three fixed land stations) were on standby. Within 32 minutes, six vessels (*Silver Charm, Lifesavers, Sunrise, Maverick, Willy Willy and Melody*) were available, with the additional Auxiliarists for assistance in logistics ready to board

In the meantime, in accordance with our Incident Response Plan, I called all Division Commanders, asking them to account for their members, giving first preference to the larger divisions (with more members to call) and those closest to the presumed area of the earthquake.

There were remarkably few problems and misunderstandings, given the scale of the exercise and the number of people involved. Except for two flotillas, all had reported by 1400 that afternoon (most by 1100). Over half the members were contacted directly (746 out of 1461). In 333 other cases, a message was left; in 109 cases, there was no answer; and in 28 cases, the number used was a wrong number. In one case, the member was in distress, 911 was called, and the member was immediately transported to the local emergency room.

Patrol Restrictions Lifted

Sector San Francisco has discontinued the requirement that vessel and land-mobile patrols be limited to weekends. The normal criteria (multi-purpose, and of benefit to the Coast Guard) will still apply, but the day of the week will not be a criterion.

Auxiliary Assistance to the Incident Management Division

Officers of the Incident Management Division have begun scheduling interviews with Auxiliarists who have volunteered to assist the Division, and who have completed the 8-hour hazardous materials first-responder course. Auxiliarists will be accompanying the active duty on landside patrols, and may be asked to assist with situation assessment in response to pollution incidents, providing "eyes on scene" for mystery sheens and reported spills. Auxiliarists will also be assisting with education and public outreach.

"Lose a Ton" Campaign

CAPT Gugg, Sector Commander, has challenged members of Sector San Francisco to "lose a ton" (collectively, that is) by June 1, 2009. Sector's divisions will be competing against each other, and CAPT Gugg has also invited the Auxiliary to participate. In response, 26 Auxiliarists (collectively weighing over 5,300 pounds) have volunteered. Who will win?? Good luck, everyone!

Jeff Price, DSO-CM

I attended NTRAIN in St. Louis and I am glad that I did. This NTRAIN provided me with some key information that the members of this District would certainly benefit from. One of the key items that was discussed was the TCO-PQS and the new procedures associated with getting new communicators up to speed on what is expected not only on a National level but also a District level. As advertised, all communicators that have passed the AUXCOM course prior to OIAUG08 have been "grandfathered" in and anyone who has taken the course after that date must take this PQS. The DVC-OT took the mentoring process to an incredible level by creating a CD that has ALL needed information and several references that will make the local mentoring process very easy. The Flotilla level Communications Officer will be the key person to the mentoring process. Once the new communicator has taken the PQS, the form that will be filled out will need to come directly to the DSO-CM for a final sign off. The DSO-CM will then submit the form to DIRAUX as a completed document. The members file will reflect the PQS being passed. There is also talk of a possible device that will be associated with this that is still under development. It should be noted that this PQS is not just for the new Communicator but also for any communicator that would like to have this qualification in their file. Please note that this PQS is just for those who move forward into the Communication program and not for those who just want to take the AUXCOM course in pursuit of their AUXOP device. The CD will be passed out at DTRAIN for ALL Flotilla and Division level Officers. The ADSO-CM has already received this CD. It is very important that this CD remain in the hands of the appointed officer and should be passed down if and when there is a new officer appointed. The CD will also be handed out to the DSO-MT and the DSO-OP.

On 07MAR09, there was a call out drill that came down through the ASC (Auxiliary Sector Coordinator) through the Sector AUXLO. This call out brought up some very serious issues that we in the Communications Department needed to address. As stated in the ASC report, it took approximately 16 minutes for the Auxiliary Watch Officer to get back with availability. This is actually a pretty good time frame. It was noted that we had several mobiles that were already available through the ARMS system and 3 fixed land stations that were not. If this were an actual emergency, the mobile would have been deployed based on the need of the Sector and the fixed land stations would have been stood up until their services were no longer needed. This system has been tested and the results were outstanding. One of the main issues that we needed to address with the ARMS system was the fact that we needed to add several

components that were not looked at in the past. So, the CMIIT team got together and put EVERYONE in the system. We placed ALL levels ofthe Auxiliaries Leadership and Management. ALL DCDR's and their VCDR's have been added with a drop link for each Division. The ARMS system has always been equipped with SMS texted style paging so ALL cells phones would receive a texted message indicating the emergency. All emails would do the same. Now, if the immediate Bay Area was effected by a catastrophe then there would be a location outside the area that would get the word out to all the other areas. There has been recent talk about another system that is making it through the Auxiliary, but it is missing one main thing and that is the local Auxiliary members that are educated with the immediate geographic. We plan on testing this out very soon but in the meantime, the ARMS system continues to be used by the Auxiliary Watch Officer at the request of the Sector Command Center. Prior to this call out, we utilized the ARMS availability list for a Saturday in January and the call was to have all listed to come up on the radio via the Districts repeater and check. All but one mobile answered the call and the rest were scattered all over northern California.

I would like to thank Chris Doutre SO-CM from Division 6. Chris and I discussed the possibility of starting a brand new Division 6 radio net. Chris not only developed the net for his Division but is also net control. The communicators in Division 6 are currently using VHF CH83A every Monday night directly after the Bay Area radio net. I encourage any and all communicators in Division 6 to get involved with this net. The net has a dual meaning. The communicators can not only be kept advised of any emergency but also they can check their radios to make sure they work correctly.

The District Communications Department was tasked with providing the Communications for this year's DTRAIN. I wasn't exactly sure what we could provide when I was asked, but after I spoke with Phil Sanchez and Mike Williams I had a clear picture. I had a meeting with Captain Gugg, Commander Davidson (Sector Response) and LCDR Lusk from the Commander center and we discussed the possibility of having the Sector Communications trailer at our event. This trailer is completely self contained and will be proudly displayed in the Double Tree parking lot. The Sector has provided some quality radios for us to use and we will also have our own personal radios for dual communications. Inside the trailer are 6 radios, a printer, and we will have wireless internet. This trailer saved the DTRAIN committee a few hundred dollars so it was a very welcome addition. My many thanks have gone to the Sector Command for the usage and they may even send some off-duty OSI's to help if needed. Some of the Sector Watch Standers actually offered to come up on their own dime just to see how efficient this trailer will be in the event they ever need to deploy it. Thank you to Phil and Mike for the trust that this would be done.

Lastly, I would like to thank ALL the mobile communicators that have been deployed to various Search and Rescue cases through out the area of responsibility. Some of these cases have been very complicated and have had heavy media attention. All the communicators have conducted themselves in the best possible professional manner. Several agencies have contacted the Sector to express their many thanks for having an Auxiliary liaison there on scene.

SPECIAL ANNOUNCEMENT FROM SECTOR SAN FRANCISCO: LCDR Lusk -Sector Command Center Chief has asked ALL members of this Auxiliary (radio operator or not) that have marine radios either in their home or vehicle to listen in whenever possible on VHF CHI6. There have been a BIG number of FALSE MAYDAYS that have come in. If the member happens to hear the MAYDAY call the member is requested to call the Sector Command Center at 415-399-3530. The Member can really make a difference because he or she can narrow the search field down dramatically if he or she gives either his or her LAT/LONG or geographic location and how strong he or she heard the transmission. Here are the offices of the ADSO-CM: All of their email addresses have been updated on the

Districts web site under Departments. As always, PLEASE START YOUR QUESTIONS AT THE DIVISION LEVEL FIRST. Please let the SO-CM have the first crack at helping you out. If you have no SO-CM then please feel free to contact one of my Officers. This just keeps with the tradition of Leadership and Management.

ADSO-CMIIT: Mr. Joe Love, The CMIIT and I will be working to update the District Comms web page. We hope to include some pictures and event items that we can look forward to in 2009. ADSO-CMIIT: Mr. Steve McCabe and Joe Love will be working to maintain the continued success of the ARMS system. We are hopeful that the Surface assets will be added this year to the system.

ADSO-CMICCIR: Kevin Sellstrom is available to assist with the type accepted radios that are now being authorized through the Auxiliary. Kevin will also be helping to improve radio relations through Sector San Francisco, Group Humboldt Bay and any active duty Station that would like to pursue radio alternatives.

ADSO-CMIHF: Mr. Stu Langs has taken this position to assist the already established HIF communicators with new frequency allocations and any information that comes down through National.

ADSO-CMIHFIMT: Mr. Morris Farmer will be assisting with Member training with HIF. This is for those who would like to get started in the HIF program. Morris is here to address your questions.

AUX RADIO NET: All Communications units are encouraged to check in and if nothing else, test their equipment to see if it all works both on the VHF marine channels as well as the repeater frequency. The net is being held at 2000 local time each Monday evening on VHF CH83A. If for some reason CH 83A is occupied then we will switch our VHF Marine remote to transmit on VHF CH 06A. The Sector Command has approved this.

AWO (AUXILIARY WATCH OFFICER): We currently have all positions filled. I will be updating the comms page on the District site when this position comes available.

ARMS (Auxiliary Resource Management System: This interactive site is fully controlled by the DSO-CM and the Auxiliary Watch Officers under the direct Supervision of the OTO, DIRAUX and the CDO at Sector SF. This site that has been established contains several Mobile responders that have stated that they want to be a part of the emergency call out process. The old style of utilizing the 11 *NI*R roster to make call outs has been replaced by this site. This site emails the communicator with his or her availability for the next 24 hours. These members are only viewed by the DSO-CM and Watch Officer to insure the privacy of the person that has signed up. We are always looking to add more communicators so if you are interested please let me know and I will get you online with this process. I cannot promise that you will be called out for the SAR, but I can tell you that your services can and will be utilized should the need arise. This service has provided Sector SF with several comms related incidents from *DI*F to SAR and everything in between. All SO-CM and FSO-CM are encouraged to pass this information along to their membership. This site is the only one of its kind in the entire Coast Guard Auxiliary. We are currently experiencing some ISP issues with the following providers: Comcast, Yahoo and

AOL. We are working to get these UNSPAMMED!

Some issues have come up in the recent past as to the exact call out process and who controls that platform. It needs to be noted that the CALL OUT is in direct response to what SECTOR SF wants and therefore they can make advisements as to who they feel can respond to their calls. I strongly encourage all communicators that wish to be called out to be in and active in this system because there is NO OTHER WAY TO GET CALLED OUT. This position is a dispatching port therefore all AWO's have been instructed to utilize the availability list AT ALL TIMES. Bottom line is that if you are not on this list, or you are and not active on the daily list then you will not be activated, period! ALL MOBILES THAT WORK UNDER ORDERS WOULD NEED TO BE IN our SYSTEM.

Ferry Vessel Audit Program

29 members attended the Ferry Vessel Audit Class at the February PCA Training Fair. We established a mentoring program which matches six experienced auditors from various points around the Bay Area - called "audit partners" with new trainees. We will be scheduling a full morning's training aboard a berthed ferry boat in Vallejo at the Baylink facility for mid-April. Year to date, we have had 16 audits, but this will increase with the good weather.

Abigail Wagg, ADSO-MS and CWO Phillips will provide mandatory Ferry Vessel Auditor training tomorrow at 10 am in the Marine Safety Workshop.

Facilities Inspection

We receive an average of one call per week for Auxiliary assistance in the Facilities Branch. A new Marine Safety Observation Program will be rolled out tomorrow afternoon at 1400 in the Marine Safety Workshop.

Regional Examination Center

We continue to assist the REC with remote locations and other support. Sacramento and Lake Tahoe have each serviced about a half dozen mariners apiece. I audited a Basic Safety Training course in Tomales and Santa Rosa in January.

Pacific Strike Team -- Richard Celia continues to stand watch every Friday at the PST.

Occupational Medical Surveillance and Evaluation Program (OMSEP)

Encourage your members to participate in this program, which is intended to protect their occupational health.

- 7. PLANNED TERMINATION OF LORAN-C PROGRAM: A separate email was sent out to all hands about this program. The President had release his Policy Budget on Feb. 26. This policy included the intention to terminate LORAN-C service. The termination of an antiquated system that is no longer required by the armed forces, the transportation sector or the nations security interest is intended to save \$36M in FY10 and \$190M over 5 years. Consistent with the Administrations pledge to eliminate unnecessary federal programs and systems, the Loran-C signal will be terminated early in FY10. NOAA's National Ocean Service (NOS) intends to eliminate LORAN-C lattices from future editions of NOS Paper Nautical Charts and Raster Navigational Charts starting in 2009.
- 8. DATES OF CHART LATEST EDITIONS: D11 Northern Region now available 1 New Chart Editions in 2009. We had only 2 New Chart Editions in 2008. See "Dates of Chart Latest Edition" Table for D11 Northern Region is on page 5. The traditional paper chart will be available in 2 to 8 weeks.

For those that have taken the eight hour TCT this year it is not necessary to take the one hour refresher. Elected officers, FSO-OP, FSO-MT, SO-OP, SO-MT, DSO-OP or DSO-MT can give the workshop as long as they are instructor qualified. Please have all those in attendance to the workshops fill out an ANSC 7039 and turn it into your IS officers. Request the IS officer to make two entries for each name, one for the OPS workshop and one for the One-Hour TCT.

<u>Both workshops will be given Sunday morning at DTRAIN.</u> WEEKDAY PATROLS:

CAPT Cullen, Sector San Francisco Deputy Commanding Officer, has approved the request to remove the restriction of patrols to weekends. Requests for patrols which meet the normal criteria (multi-purpose, of benefit to the Coast Guard, etc.) will still apply, of course, but the day of the week will not be a criterion.



Division Statistics*



-VSC Decal Shortage

Currently there is a temporary shortage of VSC Decals, and ANSC is OUT OF STOCK. Because only 150,000 VSC's are performed annually by the Auxiliary and the Power Squadron, State Farm Insurance reduced the initial distribution of decals from 400,000 to 250,000 decals. An additional supply has been requested from State Farm and there currently is no ETA.

PLEASE do not hoard decals and distribute current local stock as fairly as possible among local examiners. Each Flotilla and Division should always maintain a back-up supply. PLEASE do NOT request an additional supply from me as I do NOT have the resources available. I'm told that as soon as additional stock is received at ANSC, I'll be notified and I'll pass the word. In the meantime let's continue to share our current supply.

-Kidde Fire Extinguisher Recall

Name of product: Kidde XL Fire Extinguishers

Units: About 167,000

Distributor: Walter Kidde Portable Equipment Inc., of Mebane, N.C.

Hazard: The pressurized cylinders in the recalled fire extinguishers could lose pressure and fail

to operate. In the event of a fire, this failure could put a consumer and property at risk.

Incidents/Injuries: None reported.

Description: This recall involves the Kidde XL Fire Extinguishers with model numbers FX340SC, FX340H, FX340GW, XL5MR, FX210R, FX340SC-2, FX210W, XL2.5TCZ-4, E-340-3 and with manufacture dates between October 2007 and April 2008. The model number can be found on the label on the front of the extinguisher. The manufacture year is on the bottom of the extinguisher. If you examine an extinguisher that is one of the listed model numbers and is marked with the year 07 or 08, have the boater contact Kidde.

Sold at: Department, home, and hardware stores nationwide from October 2007 through April 2008 for about \$35.

Manufactured in: Mexico

Remedy: Consumers should immediately inspect the pressure gauge. If it points to the red zone, contact Kidde to receive a free replacement extinguisher. If the gauge is not in the red zone, but you have questions about an extinguisher within the listed model numbers, please contact Kidde for additional information. 1- Item 12: A type IV throwable PFD is no longer required

2-Item 20: A spare spark plug is only required for a 2 cycle engine.
