

MINUTES  
DISTRICT 11NR BOARD AND STAFF MEETING  
18 July 2009  
Coast Guard Island, Alameda CA

The meeting was called to order at 1035 by DCO Mike Williams. The Pledge of Allegiance to the flag was led by Steve Salmon, ASC, followed by repeating of the Coast Guard Guardian Ethos, led by Jerry McAlwee, DSO-PA.

Joyce Bell, DSO-SR called the roll, and DCO Williams declared that a quorum was present. The attendance list is attached to these minutes as Attachment A.

APPROVAL OF MINUTES:

DCO Williams called for approval of the 27 March 2009, the 15 April 2009, the 20 May 2009 and the 17 June 2009 minutes.

Motion: Charlie Duncan, P-PCA moved and Monica Eaton, DCDR-10 seconded that the minutes be approved as distributed. There being no discussion, the motion was adopted.

COMMENTS – COMO Vic Connell, ARCO-P

- NACON is in Chicago, IL, 27-30 August.
- Sometime before NACON that the National Commodore will be issuing information on how the Auxiliary will align with the new Coast Guard Modernization. The Auxiliary will be aligning with the new ForceCom. The same thing will be happening with OpCom. There will be some new title changes and positions on National Level. This needs to be approved by Congress, which will probably be in November.
- VADM Jody Breckenridge is the new PacArea Commander.

DISTRICT BOARD REPORTS:

DCO Williams called for district board reports as follows:

Mary Kirkwood, DCDR-1 – Report on file (Attachment B). The division have a great July 4 parade. Twelve members were there, along with the Pacific Strike Team and a CG helo fly-over. They held a division BBQ afterward. The division also worked with Easter Seals for their “Day on the Bay.” This included several kids programs.

Dean LaChapelle, DCDR-3 – Report on file (Attachment B). During a Whiskey Town Reservoir patrol, they found unsecured buoy protecting a waterfall and resecured it. This action kept the waters safer. The Radio 1 facility is no longer active. STN Rio Vista has picked up a FEMA trailer and uses it for a mobile comms station. Increased law enforcement has cut down on the intoxication. A flotilla member has purchased a trailer and has made it available as a mobile radio facility.

Stephen Powell, DCDR-4 – Absent.

Ray VanCleave, DCDR-5 – Report on file (Attachment B). The division is suffering from a shortage of VSC decals. They will be out by end of month. They have had a lot of OTW activities, including 18 missions in June in various areas. The PV program is going well.

Mark McLaughlin, DCDR-6 – Report on file (Attachment B). FL 61 participated with girls scouts and taught a boating safety course. Emergency response training program, the division will be meeting with Monterey Fire Academy. Maritime Security Observation Mission – two members have certified and have received orders. McLaughlin expressed some concerns about some lack of instruction regarding check-in or reporting authority. He would like some more structure and communication and a class on protocol for this mission. McLaughlin will meet with Bob Hendry, DCAPT and Neil Nevesny, CRC to receive information that is available.

Bob Hendry responded that this must be a personnel issue as all Auxiliarists who are trained for these patrols must sign a form before they can get orders which outlines structure and check-in procedures. He will send a copy of this document to all Division Commanders so they have first-hand knowledge of this.

Larry Kelley, VDCDR-7 – Report on file (Attachment B). The division is in the middle of the summer boating season, and members are augmenting the state. The division supported two regattas and a summer games event, which was involved in a freak summer storm.

Richard Thomas, DCDR-8 – Excused. Report on file (Attachment B).

Monica Eaton, DCDR-10 – Report on file (Attachment B). The division is #1 in VSCs. They are also having some difficulty getting VSC decals. They have been doing some member training and will continue to provide additional classes on a division level. They are planning training patrols, and will hold an OPTREX at Millerton on October 25-26. The division has completed 100% in bridge inspections and are working on ATONs. They participated in three parades on July 4.

Dee Dee Kincaide, DCDR-11 – Report on file (Attachment B). The division will sponsor an 8-hr TCT class on August 1. There will be additional training on August 8, which will include three speakers covering cold-water immersion, weather patterns and fire extinguishers. They have had several VSC stations and have had a lot of new VEs qualified. They are also in need of more decals. CDR Chareonsuphiphat visited the division and rode on one of the parade boats, which won the Mayor's Trophy.

Roger Haynes, DCDR-12 – Report on file (Attachment B). One flotilla, which was having difficulty finding a meeting location has now been successful in locating one. Development of a division web site to put crews in contact with boats has been delayed because of a problem with National.

Charlie Duncan, P-PCA – Report on file (Attachment B). The Poker Run has been cancelled because of low participation. The August PCA fair has 100+ registrants. Duncan recognized Gail Ramsey for her chairmanship and extensive work on the PCA fair. Duncan is looking for a replacement to chair the PCA fair program. Again, we are working with the new administration at the base to try to get the memorial going.

Wayne Farnholtz, DCAP-RES – Excused. Report on file (Attachment B).

Robert Hendry, DCAP-RBS – Report on file (Attachment B). Hendry will email copies to each DCDR of the document all have to sign before getting orders.

Rodney Collins, DCAP-SPT – Report on file (Attachment B). Nothing further to report.

Angelo Perata, COS – Report on file (Attachment B). All DCDR's have been given a copy of their units' Standing Rules dates. Some divisions and flotillas have not revised their Standing Rules for a long time. They need to be checked. The life jacket display is available for all units to use. We need to push the use of life jackets.

CWO2 Danny Kilburger, OTO – Kilburger has been acting DIRAUX for the past six weeks. He is working on a letter to update the A-fair letter verification, which covers those who perform this mission. He will be teaching a marlinspike class at the PCA Fair, and will be at the OPTREX at Strawberry. Kilburger attended the PacArea change of command, and commended McAlwee for the display that was there.

Report of Nominating Committee – DCO Williams reported that to date the following individuals have been approved for nomination to the office of DCAPT: Rodney Collins, Wayne Farnholtz and Dick Hoelle. The Nominating Committee will continue to accept new nominations.

- DCO Williams also recognized Linda and Roger Haynes for their outstanding hospitality efforts. They will be doing this for the PacArea at NACON.

Make sure all candidates who need QE's have pre-qualifications completed. Information on pre-qualifications is readily available.

Jerry McAlwee, DSO-PA – Report on file (Attachment C). The life jacket display is to support Coast Guard's RBS mission. We should become experts in life jackets. McAlwee is focusing on internal and external communications. External: PSA's. They are pre-scripted and can be localized. The PA team can help you get things going. Speakers' Bureau – work with your SO-PA. Modernization is CG in the making. ForceCom is going to be on the west coast. How are we going to augment this program. RBS is still the core, but there are many other areas where we can assist. The life jacket display is in the Coastie trailer. To check it out, contact McAlwee. To check out Coastie work through Kilburger. Documents are available on the district web site.

Roger Haynes, DSO-PE – Report on file (Attachment C). District PE goals are summarized in the Objectives report. We are down 28%, to date, on the adult graduates. The NASBLA retention survey is ongoing. We do not have geographic areas in the Auxiliary. We can teach anywhere. Use invasive species info into PE classes.

Phillip Grove, DSO-PV – Report on file (Attachment C). Nothing further to report.

Michael Lauro, DSO-VE – Excused. Report on file (Attachment C). Hendry reported for Lauro that VSC decal distribution is an issue. DCDRs, please canvas your flotillas. How many decals do you have? How many do you need? Send info to Hendry and he will help with redistribution.

Irene Wetzel, DSO-CS – Report on file (Attachment C). The email lists are tied to AUXDATA, and only those who have email addresses in AUXDATA are on the list. Send photos for “what’s new” page. Joe Love and Tony Dymond are our web site security persons.

COMO Marilyn McBain, DSO-IS – Report on file (Attachment C). The annual member letter now shows CY2009 data. The FSO/SO-IS should run copies for their members. The training management report will be updated to show currency maintenance requirements, so you won’t have to use two reports.

COMO Michael Maddox, DSO-MT – Maddox has added a member resources page to the MT web site which will give info on what manuals and equipment are needed for courses. He has created a practice test page to prepare members to take the NavRules exam, and is working on AUXNAV and AUXCOM reviews as well. Maddox introduced new ADSO-MTs who will assist with AV instruction aids.

#### **HIGHLIGHTS**

#### **DETAILS**

1. State Parks is cutting back, this will impact our Brannon Island OPTREX. Working on alternate sites.  
Whiskeytown Lake has normal safety patrols as well as the moonlight kayak events. Lake Shasta has been covered on most holidays including the 4th of July.
2. Lake Oroville will have very limited access by August. Bidwell Marina, the largest on the lake, will not have its lease extended by the State. Letters have been sent out to all 900 or so boats (ours included) that we will have 6 weeks to remove our boats before the lake level drops and access would be impossible. All marina facilities are to be removed by the end of the year. The logistics of this make the probability of this happening somewhat remote. It is unlikely that the Lime Saddle Marina could handle the load physically. Dry land parking is being negotiated with the State for boat storage until a new operator is found. What a mess.

Folsom Lake and the Sacramento River had a total of 13 mission assigned in June.

3. 101 VE's and 22 RBS visits reported.

FL 33 conducted a Boating Safety Class with the Boy Scouts and VE's of two of their boats, both passed.

FL 39 took out a Channel 7 reporter on Whiskeytown Reservoir. While on patrol, they found and secured a buoy that had broken away from the Glory Hole. The reporter took videos of their activity, which was shown on the news that evening and the next morning. As a result, they received three phone inquiries and as of this report, one has started the enrollment procedures.

4. A BS&S class was completed June 17. A majority of beginning students finished the class including the advances classes. Two of the students signed up to join the AUX.

#### **AGENCY INTERACTIONS**

1. We have a Comm. Watch Standers routinely assisting Station R/V.
2. We provided an Operational Facility for the 4<sup>th</sup> of July fireworks at Mandeville Island in support of the Delta Boating Safety Task Force Project and Sector S. F.
3. Aux Fax Crews working routinely with Sacramento P.D., State Park Ranger, Yolo and Placer County Sheriffs Marine Units on the Sacramento River and Folsom Lake. Mostly, taking over tows and other boater assistance cases allowing them to conduct more enforcement. In the North, FL-39 Boat Crews routinely work with Sheriffs, Rangers and other local LE organizations.
4. CG Station Rio Vista has a FEMA trailer they plan to use each weekend at a different location in the Delta. The five man crew will stay over night with one of their RBS-25s moored nearby. They plan to be at the DART facility (Old Radio One) on July 11/12 and August 15/16. They will conduct BUI patrols and coordinate with local law enforcement agencies

- 2 FL 52 completed an ABS class; FL 55 completed a GPS for Mariners class; and FL 57 completed a

Weekend Navigator class. All flotillas report challenges in recruiting the public to attend the classes.

- 3 After an outstanding month in May, thanks to NSBW activities, June was also a good month for RBS efforts. For example, FL 55 reported 98 Program Visits and 64 VSCs, as well as 3 CFV exams and 2 UPV exams.

2. Flotilla 6-4 has received approval for having the Pacific Grove Surf Rescue Team joining the flotilla as members of the Auxiliary. This will be a joint effort between USCGAUX, USCG, City of Monterey, and City of Pacific Grove and be segment of the local CERT program.
3. Flotilla 6-4 has been invited by Stewart Roth, Division Chief, Training and Safety/Special Operations - US7R. to address their Fire Academy students and exchange ideas on Auxiliary Membership Opportunities The students are required to perform voluntary service within the community and the Auxiliary may offer an opportunity to fulfill this requirement.

### **DETAILS**

1. Flotilla 6-1 is currently teaching the SS&S course in Morro Bay
2. Flotilla 6-4 has finished AUXPAT for member training and is continuing SS&S for PE at Station Monterey The revised AUXSCE course examinations have been provided to DIRAUX. On 23 June, a request was submitted for the examinations to DIRAUX with a date of 22 July as the date for the examination

### DISTRICT STAFF REPORTS DISTRICT 11NR BOARD AND STAFF MEETING 18 July 2009

#### **Larry Olsen, DSO-AV**

The Safety Stand Down for Aux Air has been completed and we are now back on flight status. All D11N Aux Pilots have been going through interviews conducted by Officers at San Francisco Air Station. The interviewing officers include LT Robert Fitzgerald, Flight Safety Officer; CDR Joseph Buzzella, Operations Officer; and CDR Samuel Creech, Air Station Commanding Officer. The interviews have been comprehensive, thorough, and probing. Aux Pilots have submitted resumes and information on their respective aircraft.

As of this report, nine (9) Aux Pilots have completed their interviews and have been returned to flight status. Four (4) additional Aux Pilots are going through the interview process and one Aux Pilot is out of the area until the Fall and he will have his interviews upon his return. We now have two twin-engine aircraft ready for missions, five single-engine aircraft, and one helicopter returned to service.

We are now ready to work with Aux surface vessels and Aux land mobile units. Additionally, we have received mission requests from the Air Station and Sector San Francisco.

We are up to date on our Safety Workshops as well as our swim and egress exercises. We have also been continuing our recruiting and training of new observers.

#### **Jeff Price, DSO-CM**

Here is the Communications report from the past few months. This report will include some activities that were completed.

1 I have some very good news in regard to the District repeaters. I have been advised that construction is almost complete at a location that we have been trying to get involved with for some time now. There is also a possible secondary Delta location that is being investigated. Both of these new sites will increase our ability to communicate over a very large part of the District, especially the areas that are more prone for SAR related missions.

2 I am pleased to announce that Air Station San Francisco is continuing to accept Communication Watch Standers. Currently, there are two Auxiliary members that are working exclusively with the Operations Department of this Station. The Station Commander has asked that Mike Nolan assume the responsibility of training those Auxiliary members that would like to come on board and assist. Mike is currently working on a plan that will be very user friendly for all those who would like to help. Those that are interested can contact me, and your interests will be passed along to Mike. Mike is also working on a better working relationship with the Pillar Point marina in the area of Half Moon Bay. The idea behind this was brought up by the Harbor Master. In the event of a SAR related mission and a mobile unit is deployed, the Harbormaster would like to have his office back-filled by a very experienced communicator that can handle the radio traffic while the office is empty. This would involve the Harbor Master getting the Auxiliary a key to the front door. The Auxiliary Watch Officer would essentially provide two mobile communicators to the coastal area. One would be specifically for the SAR related

mission and the other would be as described above. All of this is being worked out and Mike Nolan is the Point of Contact. This concept was talked about with previous Coast Guard officials and it was given big thumbs up at that point. 3        The Communications Department has been heavily involved with the "Delta Blitz" this year. The Sector Command Staff has approached me and has asked for my help with transporting the Sector Communications Trailer to all the event locations. In addition to transporting, the Sector Command has asked me to help with the Comms from the stand up of the trailer until the Blitz is concluded. Our role is just the radio work. Mr. Mike Nolan has offered his vehicle up as a secondary vehicle to transport the Communications Trailer. Having two vehicles on the ready to transport this trailer has proven very successful. We will be involved with the next two deployments. I welcome more Comms folks to come out and see how this is done.

4        AUGUST PCA FAIR: The Communications Department will be putting on a Communications Workshop for ALL existing Mobile providers, ALL persons working radios while underway on the water and ALL communicators that are in the air. We will be going over what the Sector expects from us and the proper "PRO-WORDS" that need to be used while transmitting over the open airwaves. The ADSO-CM from all areas will be at the workshop to answer any questions that any Member may have. This Workshop will only last a few hours so we will try to get as much stuff discussed as possible. Those who would like to test out any DIP machine are welcome to bring what they have. I will have the test units on scene.

5        FLEET WEEK 2009: I am currently looking for a very experienced communicator to work at VTS during the entire event. The right candidate will take the radio guards for ALL Aux surface assets that will be under orders. POMS does cover this, so costs for travel will be taken care of. 6        TCO-PQS: Currently, District 11NIR has a total of ZERO qualified new or grandfathered communicators. A few AUXCOMM courses have been under way and I am hopeful that we will have some new members pass this PQS so that they can move forward into the mobile program. National would like to see our numbers go up and I strongly encourage ALL Flotilla level Comms Officers to become mentors to those who would like to move forward. If anyone needs a CD for the TCO-PQS, please contact me. I handed out a few at the DTRAIN conference in March and a few in Santa Cruz last weekend.

#### SPECIAL ANNOUNCEMENT FROM SECTOR SAN FRANCISCO:

LCDR Lusk -Sector Command Center Chief has asked ALL members of this Auxiliary (radio operator or not) that have marine radios either in their home or vehicle to listen in whenever possible on VHF CH16. TherehavebeenabIGnumber of FALSE MAYDAYS that have come in. If the member happens to hear the MAYDAY call the member is requested to call the Sector Command Center at 415-399-3530. The Member can really make a difference because he or she can narrow the search field down dramatically if he or she gives either his or her LATILONG or geographic location and how strong he or she heard the transmission.

Here are the offices of the ADSO-CM: All of their email addresses have been updated on the Districts web site under Departments. As always, PLEASE START YOUR QUESTIONS AT THE DIVISION LEVEL FIRST. Please let the SO-CM have the first crack at helping you out. If you have no SO-CM then please feel free to contact one of my Officers. This just keeps with the tradition of Leadership and Management.

ADSO-CMIIT: Mr. Joe Love, The CMIIT and I will be working to update the District Comms web page. We hope to include some pictures and event items that we can look forward to in 2009.

ADSO-CMIIT: Mr. Steve McCabe and Joe Love will be working to maintain the continued success of the ARMS system. We are hopeful that the Surface assets will be added this year to the system.

ADSO-CM/CCIR: Kevin Sellstrom is available to assist with the type accepted radios that are now being authorized through the Auxiliary. Kevin will also be helping to improve radio relations through Sector San Francisco, Group Humboldt Bay and any active duty Station that would like to pursue radio alternatives. .

ADSO-CMIIIF: Mr. Stu Langs has taken this position to assist the already established HIF communicators with new frequency allocations and any information that comes down through National.

ADSO-CMIIIFIMT: Mr. Morris Farmer will be assisting with Member training with HIF. This is for those who would like to get started in the HIF program. Morris is here to address your questions.

AUX RADIO NET: All Communications units are encouraged to check in and if nothing else, test their equipment to see if it all works both on the VHF marine channels as well as the repeater frequency. The net is being held at 2000 local time each Monday evening on VHF CH83A. If for some reason CH 83A is occupied then we will switch our VHF Marine remote to transmit on VHF CH 06A. The Sector Command has approved this.

AWO (AUXILIARY WATCH OFFICER): There are 2 current vacancies in this program. All interested parties need to contact the DSO-CM if they are interested.

ARMS (Auxiliary Resource Management System: This interactive site is fully controlled by the DSOCM and the Auxiliary Watch Officers under the direct Supervision of the OTO, DIRAUX and the CDO at Sector SF. This site that has been established contains several Mobile responders that have stated that they want to be a part of the emergency call out process. The old style of utilizing the 11N/Rrosterto make call outs has been replaced by this site. This site emails the communicator with his or her availability for the next 24 hours. These members are only viewed by the DSO-CM and Watch Officer to insure the privacy of the person that has signed up. We are always looking to add more communicators so if you are interested please let me know and I will get you online with this process. I cannot promise that you will be called out for the SAR, but I can tell you that your services can and will be utilized should the need arise. This service has provided Sector SF with several comms related incidents from D/F to SAR and everything in between. All SO-CM and FSO-CM are encouraged to pass this information along to their membership. This site is the only one of its kind in the entire Coast Guard Auxiliary.

Some issues have come up in the recent past as to the exact call out process and who controls that platform. It needs to be noted that the CALL OUT is in direct response to what SECTOR SF wants and therefore they can make advisements as to who they feel can respond to their calls. I strongly encourage all communicators that wish to be called out to be in and active in this system because there is NO OTHER WAY TO GET CALLED OUT. This position is a dispatching port therefore all AWO's have been instructed to utilize the availability list AT ALL TIMES. Bottom line is that if you are not on this list, or you are and not active on the daily list then you will not be activated, period! ALL MOBILES THAT WORK UNDER ORDERS WOULD NEED TO BE IN THIS SYSTEM.

### America's Waterway Watch (AWW)

Each division and flotilla should have an AWW coordinator, and this important outreach message should be included in every public education, vessel examination and RBS program visitation activity. Nevertheless, only 3 divisions have reported any time at all, and only 32.5 hours were reported district-wide.

### Domestic Vessel Inspections

66 of 119 commercial fishing vessel exams in the region were performed by 11 of our members. 3 of our members performed 12 hours of uninspected passenger vessel (UPV) examinations. 8 members attended UPV refresher training on Wednesday, including several key coastal communities. During the quarter, we made inroads to establishing a presence for the program in the south coastal communities of Division 6 (Monterey, Santa Cruz, and Moss Landing).

### Ferry Vessel Audit Program

50 of our members have qualified as ferry vessel auditors this year, as compared with 67 last year. Our members performed 73 ferry vessel audits on 24 different ferries. We will not have a fall PCA class due to lack of classrooms, Our emphasis continues to be on the inspection of the "tourist" ferries, rather than the commuter ferries, as they are the most vulnerable for safety and security issues due to their constant usage in the summer and early fall.

The Audit Partner program pairs eight experienced auditors from the four quadrants of the Bay area with new, inexperienced auditors on their first two trips. This has brought out the best in many of our new auditors who otherwise would have not moved forward to take that first (often intimidating) first step. We also have some auditors who have shown a willingness to continue to inspect our "orphan" ferries--the ones who have odd, often difficult hours and departure locations--case in point, the Alameda Harbor Bay ferry, and some other early run ferries.

#### Facilities Inspection

Two members contributed 112 hours inspecting waterfront facilities and four members contributed 300 hours inspecting container facilities. Staffing changes in the facilities branch promise to provide more opportunities for our members to participate.

#### Marine Safety Observation Missions (MSOMs)

The MSOM program was launched this month. 36 Auxiliarists are trained. 27 patrols have been recorded and more are expected next month. (One more division and one more flotilla need training). The patrol number does not include Station Monterey, whose SO-MS advised that he and 2 trainees completed a number of patrols, but the paperwork is pending.

#### Regional Examination Center (REC)

We continue to assist the REC with administrative support. The remote location program was adversely impacted by the requirement that mariners hold Transportation Worker Identification Credential (TWIC) cards, but our members will continue to serve as designated Coast Guard officials (DCGOs), who can certify paperwork and administer oaths to new mariners.

#### Pacific Strike Team (PST)

Flotilla 14 supported the PST in its traditional role in the Novato Independence Day Parade.

#### Occupational Medical Surveillance and Evaluation Program (OMSEP)

Encourage your members to participate in this program, which is intended to protect their occupational health.

#### Marine Safety Training Ribbon (MSTR)/Trident Program

Please encourage your members to consider the MSTR as a minimum goal and qualification for marine safety officers and members interested in the program. Once they have earned the ribbon, please encourage them to continue on to serve this mission area and earn their Trident pins.

They are replacing the old ANSC 7054-Aid to Navigation Report which has become inadequate to meet the needs of the USCG in the high speed electronic age. In the Eleventh District they should make it easier & faster for any member to report any and all discrepancies information found on aids to navigation and Bridges. These new forms are designed in Excel to be completed on your own computer and attached to an e-mail to the DSO-NS to be forwarded to appropriate USCG Unit with 24 hours of observation. This information can't wait on regular mail which has taken days and even a week or more to arrive. All members will still report any **Critical discrepancy** (CG Light Listed Aids) via radio or cell phone to Sector or CGSTA ASAP. All coxswains & aid verifiers should download them to their computer for future use when needed. The Aid Verifiers will still use D11 PATON Sheet and Bridge Survey forms for their annual verifications and surveys. All these can be forms downloaded from the temporary National Navigation Systems web site <http://wwwuscgaaan.com>.

**A. NS-AN04 - AID TO NAVIGATION REPORT**

The "**NS-AN04 - Aid to Navigation Report**" form is the replacement for **ANSC 7054 - Aid to Navigation Report**, which is currently on the National Forms Web Site. This is the replacement for that form.

Any Auxiliary member can use this new form to report Discrepancies to Federal (USCG) aids to navigation throughout the year.

This new version is programmed in EXCEL. Drop-down menus and information blocks on most fields have been added in order to eliminate the need for the user to have to reference a guide or manual in order to understand what data is required in the field. I believe that this eliminates the need for an attached procedure. It's your call. We have one ready to go, if you want it. There is no need to stock this form.

This EXCEL form is currently protected but there is no security code. It should be easy to open and make any needed adjustments.

This form meets the "Professionalism" Navigation Systems Division goal by providing capability for entering data on-line or after downloading the form to the Auxiliarist home computer. It also meets our goals of providing stand-alone forms that provide drop-down menus and information blocks for the user. The next generation of this form is to add transmittal capability and possibly a way to develop reporting capability to AUXDATA.

## **B. NS-AN10 - AID OBSERVATION WORKSHEET**

The “**NS-AN10 - Aid Observation Report**” form is a new form. Simply, it is a download form that is printed out by the user’s home computer and used for recording observations on-scene at either a Federal or private aid.

All Auxiliary members and Aid Verifies should carry this new form on your vessels & land mobiles to report Discrepancies to Federal (USCG) aids to navigation throughout the year.

There is no need to stock this form. It is OK to convert this form to ADOBE since it is not updated on line. The data is converted onto a NS-AN04 - AID TO NAVIGATION REPORT and reported to the Coast Guard.

## **C. NS-PN04 PRIVATE AID TO NAVIGATION REPORT.**

The “**NS-PN04 - PRIVATE AID TO NAVIGATION REPORT**” is a new form.

Any Auxiliary member can use this new form to report Discrepancies to known private aids to navigation throughout the year.

This new version is programmed in EXCEL. Drop-down menus and information blocks on most fields have been added in order to eliminate the need for the user to have to reference a guide or manual in order to understand what data is required in the field. This form is similar to the NS-AN04 AID TO NAVIGATION REPORT except that it has a specialized section for reporting owner information for Non-Permitted Aids.

There is no need to stock this form.

This EXCEL form is currently protected but there is no security code. It should be easy to open and make any needed adjustments.

This form meets the “Professionalism” Navigation Systems Division goal by providing capability for entering data on-line or after downloading the form to the Auxiliarist home computer. It also meets our goals of providing stand-alone forms that provide drop-down menus and information blocks for the user. The next generation of this form is to add transmittal capability and possibly a way to develop reporting capability to AUXDATA.

## **D. NS-PN07 NON-PERMITTED PATON FIELD REPORT**

The “**NS-PN07 - NON-PERMITTED PATON FIELD REPORT**” is a new form.

Aid Verifiers use this new form to report unpermitted private aids to navigation throughout the year.

This new version is programmed in EXCEL. Drop-down menus and information blocks on most fields have been added in order to eliminate the need for the user to have to reference a guide or manual in order to understand what data is required in the field. Since “Non-Permitted” aid requires special owner information and normally come in groups, this form was developed to accommodate the multiple entries. This form should not be stocked.

This EXCEL form is currently protected but there is no security code. It should be easy to open and make any needed adjustments.

This form meets the “Professionalism” Navigation Systems Division goal by providing capability for entering data on-line or after downloading the form to the Auxiliarist home computer. It also meets our goals of providing stand-alone forms that provide drop-down menus and information blocks for the user. The next generation of this form is to add transmittal capability and possibly a way to develop reporting capability to AUXDATA.

#### **E. NS-BP03 BRIDGE SURVEY REPORT**

The “**NS-BP03 - BRIDGE SURVEY REPORT**” is a new form.

All Auxiliary members use this new form to report Bridge Lights & Fender Discrepancies throughout the year.

This new version is programmed in EXCEL. Drop-down menus and information blocks on most fields have been added in order to eliminate the need for the user to have to reference a guide or manual in order to understand what data is required in the field. Since Bridges have their own special list of potential discrepancies, this form was developed to accommodate these special entries. This form should not be stocked.

This EXCEL form is currently protected but there is no security code. It should be easy to open and make any needed adjustments.

This form meets the “Professionalism” Navigation Systems Division goal by providing capability for entering data on-line or after downloading the form to the Auxiliarist home computer. It also meets our goals of providing stand-alone forms that provide drop-down menus and information blocks for the user. The next generation of this form is to add transmittal capability and possibly a way to develop reporting capability to AUXDATA.

**2. DATES OF CHART LATEST EDITIONS:** D11 Northern Region now has available 4 New Chart Editions in 2009. We had only 2 New Chart Editions in 2008. See D11 Northern Region “Dates of Chart Latest Edition Table” on page 5. The **traditional** paper chart will be available in about 2 to 4 weeks after on line and print-on-demand release date.

Charts with edition dates prior to those listed in the table on page 5 are obsolete for use in navigation and Chart Updating activities. The date of a chart is of vital importance to patrol operations, aid verification and chart updating activities. When charted information becomes obsolete, further use of the chart for navigation may be dangerous. Natural and artificial changes, many of them critical, are occurring constantly; and it is important that we in the Auxiliary use the most up-to-date charts.

**Keep your charts up to date via the latest Local Notice to Mariners between new editions.**

Here's an opportunity to bring greater awareness of the **VESSEL SAFETY CHECK** program and

**RECREATIONAL BOATING SAFETY** in general, to the marine retailers and the general public. The

Association of Marina Industries has designated August 8<sup>th</sup> as the 8<sup>th</sup> annual "**NATIONAL MARINA DAY**."

The goal of National Marina Day is the education of politicians, civic leaders, and the public about the

important role the marina industry plays in cities and towns across the nation as family-friendly gateways to boating and stewards of the environment." "Without local marinas, access to our waterways would be reduced," said Jim Schofield of Boat/US a few years back. "National Marina Day helps spotlight the important role these facilities play on the waterfront. Your local marina may not participate to this degree, but I'd bet if you offered flyers, a safety booth and VSC's, they'd make space at the event. Marina operators want to participate in boating safety. As always, your comments are welcome.
