# MINUTES DISTRICT 11NR BOARD AND STAFF MEETING 12 September 2009

Coast Guard Island, Alameda CA

The meeting was called to order at 1040 by DCO Mike Williams. The Pledge of Allegiance to the flag was led by Richard Thomas, DCDR-8, followed by the Coast Guard Ethos led by Mark McLaughlin, DCDR-6.

DCO Williams introduced special guest DCO Ed Lott from Hawaii.

Joyce Bell, DSO-SR called the roll, and DCO Williams declared that a quorum was present. The attendance list is attached to these minutes as Attachment A.

#### APPROVAL OF MINUTES:

DCO Williams called for approval of the 18 July 2009 and 19 August 2009 minutes.

<u>Motion</u>: Angelo Perata, COS moved and Charlie Duncan, P-PCA seconded that the minutes be approved as distributed. There being no discussion, the motion was adopted.

#### ANNOUNCEMENTS:

#### DCO REPORT

DCO Williams reported the following:

- ODU Uniforms The untucked ODO will be available to Auxiliarists by 1 December 2009. The recommended wearout date for all other uniforms is 31 December 2012. The new sew-on collar device for the ODU uniform is either a black A or the Auxiliary logo.
- VE and PE Exams These are being updated so they will be more instructive to the candidate.
- New FC Leadership Course This is a new course being developed. A completion date is not yet available
- NACON in 2010 will probably be changed from Phoenix to San Diego
- Anyone wanting to be a chef on an Auxiliary facility may attend a school to become qualified.
- The CG is going to continue to fund the "wear it" program for life jackets in 4 states –
  one of the states selected is California
- Unit Elections Those who are seeking office need to be qualified before they stand for election. Waivers will not be granted, except in special circumstances.
- Silver-side Orders Funding There will be some instructions prepared to provide for the district staff.

DCO Williams thanked Linda and Roger Haynes for their work at NACON, and commended other district members who attended.

## COMMENTS OF DNACO-R

COMO Connell reported the following:

The Auxiliary reorganization was announced during NACON. Division and flotilla changes have already been done, so there is nothing new at that level. All of the changes were at the National level. The CG modernization is before Congress now. Changes will be done in a uniform way, which will emulate the Coast Guard structure. Elected officers will be:

Deputy National Commodore, Forcecom (still Pacific area duties)

There will be some new staff positions

N-Train – The DSO's who will attend N-Train in 2010 will be the RBS group: PA, PE, PV, VE and ASC.

#### DIRAUX REPORT

CDR David Chareonsuphiphat reported as follows:

- CDR Chareonsuphiphat briefed the new Admiral last Thursday, and the Admiral was impressed with the work the Auxiliary is doing and its value to the Coast Guard.
- Commended the work in Division 8 with the Coast Guard boat, and the fact that crew for that boat must pass regular Coast Guard qualifications.
- DIRAUX is working on a committee with concerns about the California-mandated fuel, which is causing engine failures on large ships. A large vessel not under command in our busy waters could be a problem.

#### **ELECTIONS**

DCO Williams reported that the elections will be conducted by COMO Mike Maddox.

COMO Maddox stated that there are 17 voting members present; 9 votes are required for election. Elections will be conducted in accordance with the District Standing Rules as follows:

## ARTICLE VII, DISTRICT ELECTIONS

- 7.6 A simple majority of votes cast is sufficient to elect a candidate to an office. If more than two candidates are nominated for any one district office, and no candidate receives a majority of votes on the first ballot:
  - 7.6.1 The candidate receiving the least number of votes on the first ballot will be dropped out of the voting on the second ballot. Elimination of the "low vote" candidate will continue on the next and subsequent ballots until one candidate receives a majority of the votes cast.
  - 7.6.2 If there is a tie for low votes received on any ballot, the next ballot for that office will be a "run off" between the candidates "tied for low" on the preceding ballot. The candidate receiving the highest number of votes on such next ballot run off between the "lows" will again be balloted on in the next succeeding ballot, along with all other candidates who

received a higher number of votes on the ballot preceding the tied for low ballot.

7.6.3 In the event of three successive tie votes for any District office, the presiding officer shall place all of the ballots cast on such third tied vote into a container and blindly select one ballot from the container. The teller committee then shall tally the remaining ballots, present the ballots to the presiding officer in a sealed envelope, and certify the result of the balloting to the presiding officer, who shall announce the result of that ballot and, if it be the last ballot between two candidates for any office, the final election result.

#### **DISTRICT BOARD REPORTS:**

DCO Williams called for district board reports as follows:

Mary Kirkwood, DCDR-1 – Report on file (Attachment B). Correction to the report: Steve Salmon's award was for the Pacific Central Region, not Division 1. There will be a Division OPTREX on October 3. COMO Lott attended FL 14, which is his flotilla's sister flotilla.

<u>Dean LaChapelle, DCDR-3</u> – Report on file (Attachment B). The Delta Blitz went off great in Sacramento. There were many VSC's done. They have held two training events with STN Rio Vista.

<u>Judy Esteban, DCDR-4</u> – Report on file (Attachment B). The division's election date is 23 September. Flotilla 41 just celebrated its 65<sup>th</sup> birthday party. Estaban acknowledged the work of Jimmin Chang as an interpreter for Chinese candidates aboard the Eagle for a week and interpreting for the Pacific Coast Guard in the port of Los Angeles.

Ray VanCleave, DCDR-5 – Report on file (Attachment B). On 2 August STN Vallejo initiated an early-morning call-out to the Auxiliary for a disabled vessel. <u>Dick Hoelle, DCDR-7</u> – Report on file (Attachment B). Hoelle attended FL-78 meeting to present awards. FL-72 has recruited 16 new members. FL-78 has 5 potential members. The division is growing. FL-76 will hold a NavRules class to which all of the division is invited.

<u>Richard Thomas, DCDR-8</u> – Report on file (Attachment B). Crescent City members must complete the Coast Guard quals in order to crew on the RBS. We have our first official watchstander. We also have four 4 crew candidates and 4 coxswain candidates. There will be an OPTREX during Fleet Week. Everyone is invited.

Monica Eaton, DCDR-10 – The Division is out today participating in another push to get the RBS message out to the public. There will be an OPTREX 24-25 October at Millerton Lake.

<u>Dee Dee Kincade, DCDR-11</u> – Report on file (Attachment B). The Division goal has been social media and getting the word out. They are now experimenting with videos, and have completed a video which is on line. The Division is working many regatta events right now. 50% of the patrol hours are regatta events. They are doing kayak safety classes, and are having good results working with Associations for PE classes.

Roger Haynes, DCDR-12 – Report on file (Attachment B). The Division is scheduling a series of air, land and sea classes.

<u>Charlie Duncan, P-PCA</u> – Report on file (Attachment B). Mary Kirkwood is new PCA Fair chairman. We have the funds for the memorial. Elections for P-PCA and VP-PCA will be held in November.

<u>Rodney Collins, DCAP-SPT</u> – Report on file (Attachment B). Division 1 elections will be on 28 October. There is a call for *Northwind* articles.

<u>Angelo Perata, COS</u> – Report on file (Attachment B). We have just celebrated the 70<sup>th</sup> Anniversary of Auxiliary. Life jacket program information will be coming out shortly, and will be passed on when received.

<u>CDR David Chareonsuphiphat, DIRAUX</u> – Reviewed the summer's activities, which included visits to Lake Tahoe, Crescent City, a Norfolk VA training session, Utah and NACON.

<u>CWO2 Danny Kilburger, OTO</u> – As PPE equipment, DIRAUX will provide a PFD, bag, whistle and signal mirror to each boat crew member. If you have division members using their own personal equipment who have not received equipment from DIRAUX, have them contact DIRAUX (Stacy Curtin), and we'll send the equipment to you. Members need to wear the proper uniform on patrols and when being qualified.

At NACON all of the OTOs agreed that the three-year requal program needs to be kept. Procedures for performing specific evolutions are in the *Boat Crew Seamanship Manual* and the *Boat Crew Qualification Guide*. These manuals will give you everything you need to know.

## **DETAILS**

- 1. FL 53 member Doug Burke reported having an opportunity to save a Travis AFB Airman's life while he was fishing near Edo's Harbor. The Airmen, while attempting to pull anchor ended up tangling the rode in the boats prop, and subsequently fell overboard. He was clutching a throw cushion as the current carried him down the river when he was pulled to safety aboard Doug's boat.
- 2. Earlier this year, Station Bodega Bay requested that the Auxiliary assist them by patrolling Tomales Bay. Although FL 55 patrols the Bodega Bay area with six facilities, none were suitable for the very shallow waters of Tomales Bay. However, FL 55

members committed themselves to finding a solution to the problem. One of the members acquired an older, shallow-draft Boston Whaler. Other members pitched in to equip and make ready the boat to be an operational facility. Last month, Auxiliary vessel "Sea Scum" was ready, and two patrols were conducted. Upon seeing the Auxiliary on patrol, a Marin County Park Ranger expressed his gratitude that the "Coast Guard" was there.

- 3. At approximately 0750 on 2 AUG, we received a call from the Auxiliary Liaison at Station Vallejo requesting Auxiliary assistance to respond to a call from a disabled vessel on Suisun Bay. By 0917, FL 51 member Mike Ungersma and his crew were underway. The disabled vessel was located and safely towed to the Benicia Marina, and the mission secured at 1245.
- 4. Flotilla 52 had their first meeting last month at their new home, the Napa Valley Yacht Club.

#### **AGENCY INTERACTIONS**

Four California Highway Patrol officers passed the ABS class conducted by FL 51 at the Napa Airport CHP facility. The CHP operates two trailerable boats, two helicopters, and two fixed wing aircraft from the facility.

For endurance swimmers, it is more than just beautiful, it is a great challenge. I think that you'll hear from more swimmers as this type of swimming becomes more popular and as more swimmers train for the English Channel. The only surprise I had on the swim was how cold the up swells were near Incline Village. Advice I'll give to other swimmers is to drink hot tea 3 miles out to keep their core warm.

On Friday August 28th, Patti Bauernfeind, Director in Product Marketing, completed a long-time goal of swimming the 22 mile length of Lake Tahoe in 10 hours and 39 minutes – setting a new record! She swam from Camp Richardson South Lake to Incline Village North Lake Tahoe. This is 22 miles at 6200 feet elevation. She is only the 15th recorded swimmer to swim the length of Tahoe but only 4 have swum between the two farthest points on the lake. The swim is like running an ultra marathon; a marathon swim is 10K or 6.2 miles and the Tahoe swim were 3+ times this and then some.

All Division CM Officers will be notified and those that have the proper radios will be included with the testing. We have acquired a new set of frequencies for this specific repeater. Most of them have been uploaded by the Repeater ADSO and that took place at the last PCA fair.
- 2. Mike Nolan and I met with the Harbormaster at Pillar Point to discuss the operational procedures that will be put in place. As indicated in the last report, the Auxiliary Mobile Communicators will now be back filling the Harbormasters Office while the Harbormaster is underway on Search and Rescue related matters. The Mobile Communicators job will be well defined. If there is a need for coverage, the AWO will dispatch two mobile units to the San Mateo County coast. One Mobile Communicator will be tasked with maintaining the Harbormasters Office and the other will be tasked to the incident. All

interested Mobile Communicators are requested to contact Mike Nolan at: mobile1@irishlad.com

- 3. The Communications Department was heavily involved with the "Delta Blitz" this year. The Sector Command Staff approached me and has asked for my help with transporting the Sector Communications Trailer to all three event locations. In addition to transporting, the Sector Command has asked me to help with the Comms from the stand up of the trailer until the Blitz is concluded. Our role is just the radio work. Mr. Mike Nolan has offered his vehicle up as a secondary vehicle to transport the Communications Trailer. Having two vehicles on the ready to transport this trailer has proven very successful. We were involved with all three deployments. I look forward to next year!
- 4. <u>AUGUST PCA FAIR</u>: We had a very nice turn out at the PCA Fair. We had representation from just about all the Divisions. We went over items such as how to set up a landing zone for helicopters, PRO-WORDS (what not to say) and other radio related topics. Kevin Sellstrom ADSO-CM for radios and repeaters also provided some key information in regards to the type of radio that can be utilized by the Auxiliary. A copy of the power point was available for those who attended the class. One of the other items that we discussed was the restructure of the Mobile Call signs. I have been working with a few of my fellow DSO-CMs from around the country and I believe we have found something that will be very user friendly to both the Auxiliary and the Coast Guard. I will be rolling out the new call signs hopefully by 01JAN10
- 5. FLEET WEEK **2009**: ALL positions for Communicators have now been filled. There will be no additions this year. All assigned Communicators have specific tasks for this event.
- 6. <u>TCO-PQS</u>: I am extremely pleased to announce that we now have a total of three Communicators that have taken and passed the PQS. Their information has been entered into the database. We have two more in the pipeline which will be done by the end of September. We had ZERO in July so progress is being made and I thank all who have been pushing this very much!
- 7. AUXCOMM CLASS: There will be a two day AUXCOMM Class taking place at Coast Guard Island on 12SEPT09 and 13SEPT09. Please contact Mr. Jim VanFleet if you are interested in getting qualified. I am not sure if the class is filled or not. His contact info is: intrepidi@comcast.net

# SPECIAL ANNOUNCEMENT FROM SECTOR SAN FRANCISCO:

LCDR Lusk – Sector Command Center Chief has asked ALL members of this Auxiliary (radio operator or not) that have marine radios either in their home or vehicle to listen in whenever possible on VHF CH16. There have been a BIG number of FALSE MAYDAYS that have come in. If the member happens to hear the MAYDAY call the member is requested to call the Sector Command Center at 415-399-3530. The Member can really make a difference because he or she can narrow the search field down dramatically if he or she gives either his or her LAT/LONG or geographic location and how strong he or she heard the transmission.

Here are the offices of the ADSO-CM: All of their email addresses have been updated on the Districts web site under Departments. As always, PLEASE START YOUR QUESTIONS AT THE DIVISION LEVEL FIRST. Please let the SO-CM have the first crack at helping you out. If

you have no SO-CM then please feel free to contact one of my Officers. This just keeps with the tradition of Leadership and Management.

<u>ADSO-CM/IT</u>: Mr. Joe Love, The CM/IT and I will be working to update the District Comms web page. We hope to include some pictures and event items that we can look forward to in 2009. <u>ADSO-CM/IT</u>: Mr. Steve McCabe and Joe Love will be working to maintain the continued success of the ARMS system. We are hopeful that the Surface assets will be added this year to the system.

<u>ADSO-CM/CC/R</u>: Kevin Sellstrom is available to assist with the type accepted radios that are now being authorized through the Auxiliary. Kevin will also be helping to improve radio relations through Sector San Francisco, Group Humboldt Bay and any active duty Station that would like to pursue radio alternatives.

<u>ADSO-CM/HF:</u> Mr. Stu Langs has taken this position to assist the already established H/F communicators with new frequency allocations and any information that comes down through National.

<u>ADSO-CM/HF/MT</u>: Mr. Morris Farmer will be assisting with Member training with H/F. This is for those who would like to get started in the H/F program. Morris is here to address your questions.

<u>AUX RADIO NET</u>: All Communications units are encouraged to check in and if nothing else, test their equipment to see if it all works both on the VHF marine channels as well as the repeater frequency. The net is being held at 2000 local time each Monday evening on VHF CH83A. If for some reason CH 83A is occupied then we will switch our VHF Marine remote to transmit on VHF CH 06A. The Sector Command has approved this. The so called "WEST DELTA NET" has been terminated. This net was scheduled at 1900 each Monday. <u>Once the new repeater system gets installed</u>, we will be having an additional net in the week.

<u>AWO (AUXILIARY WATCH OFFICER):</u> There are 2 current vacancies in this program. All interested parties need to contact the DSO-CM.

ARMS (Auxiliary Resource Management System: This interactive site is fully controlled by the DSO-CM and the Auxiliary Watch Officers under the direct Supervision of the OTO, DIRAUX and the CDO at Sector SF. This site that has been established contains several Mobile responders that have stated that they want to be a part of the emergency call out process. The old style of utilizing the 11 N/R roster to make call outs has been replaced by this site. This site emails the communicator with his or her availability for the next 24 hours. These members are only viewed by the DSO-CM and Watch Officer to insure the privacy of the person that has signed up. We are always looking to add more communicators so if you are interested please let me know and I will get you online with this process. I cannot promise that you will be called out for the SAR, but I can tell you that your services can and will be utilized should the need arise. This service has provided Sector SF with several comms related incidents from D/F to SAR and everything in between. All SO-CM and FSO-CM are encouraged to pass this information along to their membership. This site is the only one of its kind in the entire Coast Guard Auxiliary.

Some issues have come up in the recent past as to the exact call out process and who controls that platform. It needs to be noted that the CALL OUT is in direct response to what SECTOR SF wants and therefore they can make advisements as to who they feel can respond to their calls. I strongly encourage all communicators that wish to be called out to be in and active in this system because there is NO OTHER WAY TO GET CALLED OUT. This position is a dispatching port therefore all AWO's have been instructed to utilize the availability list AT ALL TIMES. Bottom line is that if you are not on this list, or you are and not active on the daily list

then you will not be activated, period! ALL MOBILES THAT WORK UNDER ORDERS WOULD NEED TO BE IN THIS SYSTEM.

1. <u>REQUEST FOR DIGITAL PHOTOGRAPHS OF ALL BRIDGES</u>: The Auxiliary has received a request from <u>D11 (dpw) Bridge Section</u> for two (2) current clear and sharp daylight digital photographs of the straight on approach to all bridges one up and one downstream as seen from a vessels. A good opportunity to photograph bridges is while already out on an official patrol. Some of the key aspects of this effort are:

<u>Locations</u> - This request is from <u>D11 (dpw) Bridge Section</u> for their AOR. Basically that would mean <u>all</u> waterway bridges in San Francisco Bay area up to inland areas including the Sacramento and San Joaquin Rivers and sloughs and up and down the coast of California.

<u>Safety First</u> - Ignore opportunities if there are ANY safety concerns. Perform during the course of normal Safety or ATON patrols - Separate orders will not be issued for this activity. The photos are only to be taken while you are already out there on official orders for a patrol, with the boat and crew fully identified as CG Auxiliary, and when and where it is convenient to do so without separate patrol diversions from original purposes and duties of your patrol, deviating from normal courses, or unsafe in any way. In other words, only as an opportunity presents itself while you are otherwise out there.

<u>Photo Subjects & Good Photos</u> –Try to get two (2) clear & sharp digital photographs showing the bridge main straight on approach channel showing from bank to bank in narrow waterways one up and one downstream. For large waterway bridges photographs showing the main straight on channel approach with at less one bridge section on each side of the approach. Always have the bridge straight on approach in the center of the photograph. The Bridge should fill at least 2/3rds of the shot (but do not crop or alter the photo)

<u>Photo Submission</u> – Forward current clear & sharp digital photos to James B. Duncan, DSO-NS (<u>dvc.on@comcast.net</u>) by e-mail only or on a CD disk. If you take any relevant photos, then include in the cover email with your submission what information you happen to notice about the bridge that would identify it. (Bridge name, waterway name, the approximate location, date and time of the photo, etc)

2. <u>DATES OF CHART LATEST EDITIONS:</u> D11 Northern Region now has available 5 New Chart Editions in 2009. We had only 2 New Chart Editions in 2008. See "Dates of Chart Latest Edition" Table for D11 Northern Region is on page 10. The <u>traditional</u> paper chart will be available in 2 to 8 weeks.

3. CHART 18652 LATEST EDITION HAS BIG NEW CHANGES: This is the third and last of our 3 small craft facility charts that you will notice a big change in this new 53<sup>rd</sup> Edition of chart 18652 covering the San Francisco Bay to Antioch. All Operational vessels, when you get this new chart, look it over very closely! You will be very surprised.

NOAA, Marine Chart Division issued a cartographic order (CO 002/05) and it is now being implemented. Starting with 2009 charts it's specifying that only small craft facilities that meet the following five criteria will be charted from now on:

- 1. Open to the public.
- 2. Sell gasoline or diesel fuel.

- 3. Have a pump out facility.
- 4. Have transient berths or moorings.
- 5. Give an approach depth and an alongside depth.

According to NOAA, Marine Chart Division if a small craft facility doesn't meet these criteria, they are of little value to the mariner and thus will not be included in the tabulation table on the chart. Thousands of small craft facilities (marinas) have been removed from the tabulations table (includes the magenta numbers on the chart showing the marinas location) on the chart because they don't meet these five criteria.

Chart 18652 has lost about 64 marina locations from the 34<sup>th</sup> edition to 35<sup>th</sup> edition. You can't go the web address below because it's not on the NOAA On-Line-Viewer of the Pacific Coast. You can also check on chart 18661 & 18662 at http://www.nauticalcharts.noaa.gov/mcd/OnLineViewer.html

**Note:** Out of 84 marinas in the 34<sup>th</sup> edition, now only the 20 marinas (listed below) are in the new 35<sup>th</sup> edition of the San Francisco Bay to Antioch Small Craft Facilities Chart 18652.

4. AID VERIFIERS QUALIFIED OR AID VERIFIERS RE-CERTIFIED IN 2004 it is your time to take the Open Book 5-Year Re-certification exam. Aid Verifiers must recertification every 5-year. The 5-year Open Book Aid Verifier Re-certification Exam can be emailed or mailed to any Aid Verifier requesting to take their 5-year Re-certification. I've emailed the list of Aid Verifiers due this year to all SO-NS. SO-NSs please confirm that these Aid Verifiers are aware of this requirement. Please have then contact me (DSO-NS) for a copy

of the 5-year Open Book Aid Verifier Re-certification Exam or that they don't wish to re-certify. They only have 4 months to re-certify!!!!

The date of a chart is of vital importance to patrol operations, aid verification and chart updating activities. When charted information becomes obsolete, further use of the chart for navigation may be dangerous. Natural and artificial changes, many of them critical, are occurring constantly; and it is important that we in the Auxiliary use the most up-to-date charts.

Keep your charts up to date via the latest Local Notice to Mariners between new editions.

7. First Repeater Make Photographs Really Work For You: Kevin Redden, BC-MNB. We've all heard the mantra that "a picture says a thousand words". When reporting an aid or bridge discrepancy or chart updating we must convey the issue we observe in the field to a person sitting in an office who in many cases has never seen the aid, bridge or chart updating that we are reporting on. We have to be able to draw a mental picture in that person's mind of the problem we are observing. This is where photographs are invaluable.

In reporting discrepancies however, there is an easy way to make a picture speak two thousand words! By simply putting the photograph into PowerPoint, and adding captions and arrows, the story we are trying to tell jumps right off the page, letting the reader know exactly what we are trying to report.

#### PHOTO MISSION:

We can do more than put holes in the water, the below from Jim Duncan, DSO-NS

1. Request for Digital Photographs of all Bridges. The Auxiliary has received a request from D11 (dpw) Bridge Section for two (2) current clear and sharp daylight digital photographs of the straight on approach to all bridges one up and one downstream, by facilities while on patrols. A good opportunity to photograph bridges is while already out on an official patrol. Some of the key points of this request are:

<u>Locations</u> - This request is from D11 (dpw) Bridge Section for their AOR. Basically that would mean <u>all</u> waterway bridges in San Francisco Bay area up to inland areas including the Sacramento and San Joaquin Rivers and sloughs and up and down the coast of California.

<u>Safety First</u> - Ignore photo opportunities if there are ANY safety concerns. Gather photos during the course of normal Safety or ATON patrols - Separate orders will not be issued for this activity. The photos are only to be taken while you are already out there patrolling under official orders, with the boat and crew fully identified as CG Auxiliary

Take photos when and where it is convenient to do so without separate patrols diversions from original purposes and duties of a patrol, deviating from normal courses, or unsafe in any way. In other words, only as an opportunity presents itself while you are otherwise out there.

Photo Subjects & Good Photos –Try to get two (2) the clear & sharp digital photograph showing the bridge's main approach channel from bank to bank in narrow waterways, one up and one downstream. For large waterway bridges photographs showing the main channel approach with at least one bridge section on each side of the approach. Always have the bridge, straight on approach, in the center of the photograph. The Bridge should fill at least 2/3rds of the shot (but do not crop or alter the photo)

. <u>Photo Submission</u> – Forward current, clear & sharp digital photos to James B Duncan, DSO-NS (<u>dvc.on@comcast.net</u>). If you take any relevant photos, then Include in the cover email with your submission what information you happen to notice about the bridge that would identify it. (Bridge name, waterway name, the approximate location, date and time of the photo, possible damage needing correction eta.)

## REYR????

Sorry to be redundant, but the office has received three more complaints from members who did their make-up hours but failed to send in the MT-3 to DIRAUX so the REYR status could be removed, thus the below (*again*).

## **REYR / REWK PROPER WAY TO REGAIN OPERATIONAL STATUS:**

REYR is when you have a lack of a currency maintenance requirement recorded in AUXDATA for the qualification you have worked so hard to achieve. This may be due to lack of hours

underway and/or tasks not accomplished (TCT, Workshops, and ICS courses as examples). REWK is when you have not done the required workshops in a specified time and at the end of the year REWK will change to REYR. To regain Operational Status you must do the required time; this should be entered into AUXDATA showing you as a Trainee. Then submit to DIRAUX the Form MT-3 (1-09). This form is on the District Web Site:

http://d11nuscgaux.info/docs/Downloads/D11NR-MT3.pdf. Only the Director's office can remove the REYR or REWK. This procedure is being followed for Boat Crew, Coxswain or PWC Operator. If the REYR is due to lack of hours from the prior year, these hours need to be made up. Be sure to get this year's requirement hours in also or you will end up REYR again in January.

Congratulations to the 12 recent graduates of the Vessel Examiner class at the August PCA Fair! You'll find their names listed further in the newsletter. So that the qualification process with

the recent graduates and other new examiners goes smoothly, I'd like to take a minute to review the qualification process.

After passing the VE exam whether in the classroom or the on-line exam, the trainee needs to complete at least 5 supervised VSC's under the guidance of a qualified examiner. The VSC's can be performed all in one outing (the preferred method) or over several outings. The qualifying examiner receives credit for these VSC's on the 7038 form with the name of the trainee and member number listed on top of the form and in the REMARKS section. The 7038 should only show VSC's performed with the trainee. All

your other VSC activity should be listed on a separate 7038. In addition to the 7038, the VE portion of the District MT-2 form MUST be filled out **COMPLETELY** by the qualifying examiner and then returned to the trainee so the Flotilla Commander can sign and date the form who then returns it to the trainee. After making a copy, the trainee can either fax or mail the MT-2 form to the DIRAUX office. The MT-2 form along with many other aids can be found on your D11NR website: <a href="http://rbsafety.d11nuscqaux.info/ve.html">http://rbsafety.d11nuscqaux.info/ve.html</a>.

The qualifying examiner's 7038 with the trainee information should be promptly submitted thru the I.S. system. It is important to note that each step must be completed correctly and in a timely manner or an unnecessary delay will be created. Once the trainee has completed the supervised exams, they can continue performing VSC's that day. There are many possible methods to train a new examiner. Keep in mind that even though the trainee passed the written test, they may not be able to properly use the knowledge. In addition, the trainee may not possess the confidence to greet the boater or correctly complete the VSC form. With this in mind, I prefer the trainee observe me greeting the boater and observe me performing at least the 1 and 2 exam. Under your supervision they can then perform at least the 3 thru 5 exam, maybe more. As the trainee performs these exams, each should be critiqued away from any other VSC activity so as not to embarrass the trainee. Hopefully, each succeeding examination is an improvement over the previous Checks. Just a couple of quick reminders:

- 1) All examiners need to remember to contact your FSO-VE, VFC, or FC if you plan to perform a VSC on a boat or spend hours at your favorite marina/launch ramp by yourself. This notification-not permission is so that you are covered by the Coast Guard insurance if something should happen.
- 2) All examiners at a VSC station should dress alike and dress correctly. The FSO-VE or the person establishing the station establishes the uniform of the day. The light blue golf shirt is an excellent substitute for the tropical blue shirt. Remember NO devices are worn on a Tilly hat or on the light blue golf shirt, as these are NOT uniform items.
- 3) Though not required, for YOUR safety a PFD should be worn when working around any docks or climbing aboard any vessels. It may be the new inflatable type V that we just received or a type III or a float coat.
- 4) Finally, we perform VSC's-Vessel Safety Checks, not VE's. VE's are you and I-"Vessel Examiners".

Even though it's late in the season and water levels are dropping, let's get a crew together, other equipment and schedule a VSC station to help out the boater-that's what we agreed to do when we joined the Coast Guard Auxiliary! As always, your comments are welcome.



# **Surface Vessel Support**

The Auxiliary responded to an unusually large number of requests from Sector San Francisco for surface vessel support last month. In several cases, the surface vessels were assisted by land-mobiles, air patrols and Auxiliarists volunteering for other roles.

On August 16, there was a "Million Boat Float" on the Sacramento River, protesting plans to divert water from Northern California to Southern California (in the event, only about 27 boats participated). Four Auxiliary vessels (*Meanwhile, This Side Up, Dark Matter* and *Venture*) helped maintain safety, assisted by an Auxiliary air patrol and land-mobiles on the ground.

On August 19-20, Sector conducted the "Coyoto Shield Full Scale Exercise" at the Military Ocean Terminal Concord (MOTCO). *Osprey* helped maintain a safety zone on the river, and four Auxiliarists (Jack Kane, Jim Losl, Richard Saber and Leonard Lee) played the role of injured protesters ashore.

On August 28, Sector requested assistance in maintaining a safety zone around a sunken tug off Treasure Island, and *Sunrise* diverted from helicopter training to fill that request.

On August 29, *This Side Up* and *Mucho Gusto* helped enforce a "no wake" zone around a damaged levee on the San Joaquin River.

On September 4-7, five vessels (*Harmony, String of Pearls, Lopaka Nane, Sunrise* and *Farallon*) provided transportation to and from Yerba Buena Island during the Bay Bridge closure,

maintained a safety zone around the construction area and the Coast Guard base, and responded to at least one SAR case.

And on September 10, four vessels (*Footloose, Spending 3.2, Bella Luna* and *Chamaeleon*) participated in an exercise designed to test the ability of special equipment to detect the presence of a radiation source on a small recreational vessel.

Auxiliary vessels continued to support training at Sector's small boat stations as well. In the case of Station Bodega Bay, these activities have been expanded to include night patrols.

#### **Support to Contingency Planning Department**

Support to Sector's Contingency Planning Department has been expanded, with the addition of new member Jim Higgins to the Contingency Planning Board, and as an observer and evaluator for the ongoing Operation Golden Guardian.

# MSOM Patrols

The number of shoreside Marine Safety Observation Missions has been steadily increasing. The missions are appreciated by the small boat stations, since they are in direct support of Sector's Operation Focused Lens, and each MSOM visit to an OFL site means one less visit is required by that station.

# **America's Waterway Watch Surge**

Sector conducted a "surge" operation called Operation Patriot's Resolve on September 10-12, and requested the Auxiliary's support with expanded AWW efforts. In response, a number of Auxiliarists are planning (or have conducted) special presentations and visits during that period.
