US COAST GUARD AUXILIARY DISTRICT 11N BOARD AND STAFF MEETING Rohnert Park, CA 26 March 2010

The meeting was called to order at 1400 by DCO Mike Williams. The Pledge of Allegiance was led by Robert Firehock, DSO-LP.

Joyce Bell, DSO-SR called the roll, and DCO Williams declared that a quorum was present. The attendance list is attached to these minutes as Attachment A.

APPROVAL OF MINUTES:

DCO Williams called for approval of the 16 January 2010 and the 10 February 2010 minutes.

<u>Motion</u>: Angelo Perata, COS moved and Roger Haynes, DCDR-12 seconded that the minutes be approved as distributed. There being no discussion, the motion was adopted.

COMMENTS - COMO Vic Connell, IPDCO/DNACO-R

COMO Connell stated that there have been many changes in the Coast Guard, and also in the Auxiliary. He expressed confidence that we will enjoy accepting the challenge.

DISTRICT BOARD REPORTS

DCO Williams called for district board reports as follows:

<u>Mary Kirkwood, DCDR-1</u> – Report on file (Attachment B). The division's spring OPTREX will be on 12 June. Kirkwood reviewed the division's strategic goals. In recruitment and retention, they will initiate 1st contact within 2 weeks of receiving notice of an interest individual. Each flotilla has set a goal that the FC, VFC, FSO-MT and FSO-PV will all obtain the RBS ribbon during the year.

<u>Bob Gwaltney, DCDR-3</u> – Report on file (Attachment B). The division OPTREX is scheduled for 29 April. They plan an NSBW activity at Whiskeytown Lake with a CG helo and the National Guard bridge-building detail.

<u>Judy Esteban for Paul Verveniotis, DCDR-4</u> – Excused. Report on file (Attachment B). FL 42 received a National award for being 63 years old. They were given a US flag which was flown over the national capitol.

<u>Curtis Han, DCDR-5</u> – Report on file (Attachment B). The RBS program is going strong. They are focusing highly on the dock walker program this year. 18 attended the training program, and

there will be one more session in April. Two OPTREX are planned: 24 April (training only) and 26 June (QE only).

<u>Mark McLaughlin, DCDR-6</u> – Report on file (Attachment B). The division participated in a new service operations category – tsunami patrol. The earthquake in Chile resulted in a tsunami in Santa Cruz. An Auxiliary vessel became incident commander for the event. Several vessels were on patrol. It was a great opportunity to practice, even though the incoming tsunami was only 4' high.

<u>Larry Kelley, DCDR-7</u> — Report on file (Attachment B). We are just coming into the boating season. The division plans two OPTREXs this year — June and early August. At the February boat show, the division hosted a booth. 27 members stood one or more watches at the boat show, with 112 man hours. We had sign-up sheets for VSC, PE and membership, and are picking up new members across the board for all flotillas. The division is planning VSC stations at four reservoirs during NSBW.

<u>Richard Thomas, DCDR-8</u> – Report on file (Attachment B). Our St Patrick's Day feed at Noyo River very successful, with a lot of kids in attendance. The Crescent City flotilla had spaghetti feed that was very successful.

<u>Rod Rollins, DCDR-10</u> – Report on file (Attachment B). Mike Lauro is getting close to a career total of 10,000 VSCs.

<u>David Law, DCDR-11</u> – Report on file (Attachment B). We just completed four week-ends of a fishing derby at Pyramid Lake.

Roger Haynes, DCDR-12 – Report on file (Attachment B). Members of the division worked with AUX Air during a recent patrol. The experience was very useful. The division has taught Suddenly In Command sessions at Brannan Island State Park on four occasions.

<u>Judy Esteban, P-PCA</u> – Report on file (Attachment B). We had a very successful PCA Fair, thanks to Mary Kirkwood, Chairman of the fair. If any has a suggestion for a special class for the August PCA Fair, please let Judy or Mary know. Esteban presented checks for \$50 to Flotillas 5-3 and 6-10 who tied for the highest PCA Fair attendance.

<u>Rodney Collins, DCAP-RBS</u> – Report on file (Attachment B). Collins needs the name of the NSBW chairmen for each division. We expect a great RBS year. We are working very hard in AWW and all of the safety missions.

<u>Wayne Farnholtz, DCAP-RES</u> – Report on file (Attachment B). Farnholtz commend all of the DSO's who are involved in operations for their collaborative efforts toward the joint training exercise at Brannan Island later this year with OPS, COMMS and AV.

<u>Dean LaChapelle, DCAPT-SPT</u> – Report on file (Attachment B). Don't forget the district store is

open for business during D-Train. LaChapelle is working on a Heraldry handbook project. It will provide some guidelines for units who have flags, banners or patches. LaChapelle would like picture of any flags or patches that divisions or flotilla may currently have. Also please include dimensions of any flag or patches which can be used to set standards in the guide that is being prepared.

<u>Angelo Perata, COS</u> – Perata is working with Mike Maddox, DSO-MT to create some live and animated visual aids for use in PE classes. Saturday afternoon at 1600 we will have an all-hands meeting with the District Commander, RDML Castillo in Salon 1-4. The Saturday night banquet emcee will be Bob Peterson.

DCO Williams stated that the Admiral will respond to questions following his speech. If you would like to ask him a question, make sure your questions are appropriate for him. COMO Connell stated that the proper protocol is: Stand up. Identify self. Ask a thoughtful question.

<u>CDR David Chareonsuphiphat, DIRAUX</u> – Members are to be commended for the great job everyone is doing. CDR Chareonsuphiphat recognized the DIRAUX office personnel, plus volunteers Larry Draper, LeRoy Cross, Wayne and Anita Farnholtz and Gail Ramsey. He also recognized Auxiliarists in Division 7 who provided aid to families of the crew, and notified DIRAUX of what was going on after the Helo 860 crash in Utah.

<u>CWO2 Danny Kilburger, OTO</u> – Thanks for the data call regarding info on personal purchase of PPE equipment. Out of 1,477 active-duty members, 503 PPE were personally purchased, which is 34% of all personnel. This information will be reporting to headquarters. This information is part of the data that will be used to determine whether or not Auxiliarists can wear their PPE when not on patrol. The ICS-210 deadline is 1 April 2010. Nearly all Coxswains in D11N have it. Headquarters is sending an ICS-210 instructor to remote areas to give the class. If you have people working on ops who need the course, this instructor will be available from mid-April to the 1st week in May. Contact Kilburger ASAP if you would like to set up a class. Stacy Curtin and Rachel Zamora were recognized.

DISTRICT STAFF REPORTS

Angelo Perata, COS directed the DCAPT's to call for their staff reports as follows:

<u>Larry Olsen, DSO-AV</u> —We have been coordinating exercises with surface and land mobiles. We are looking forward to doing more of them.

<u>Jeff Price</u>, <u>DSO-CM</u> – Report on file (Attachment C). The communications trailer was not able to be here, because of last-minute scheduling changes.

COMO Gail Ramsey, DSO-OP – Report on file (Attachment C). Don't forget the operations

workshop will be Sunday morning. The one-hour TCT workshop will be immediately after. Budget problems will be affecting the materials that we will be receiving from California. To assist in saving state personnel costs, only one representative from each division is asked to request materials from California State Department of Waterways.

Rod Collins, DCAPT-RBS called for the following staff reports:

<u>Sue Fry, DSO-MS</u> – Report on file (Attachment C). AWW was 6 visits per quarter, now it is 2. Marine safety is one of the most vital areas of our program. IIMS testing is set for tomorrow, thanks to CWO Danny Kilburger and Tina Perry for agreeing to proctor the exam. There are 300 CG license holders in northern California for the commercial vessel exams; however the fishing industry is collapsing because of the economy, so many are not going out this year.

Jim Duncan, DSO-NS – Excused. Report on file (Attachment C).

Mike Lauro, DSO-VE – Report on file (Attachment C). There will be an RBS workshop tomorrow. Lauro has created a VSC brochure which is in Word format and will be available for VE's to download. There is a pilot program for canoes and kayaks. All VEs will receive via email a separate VSC form just for canoes and kayaks. This is a National test program to see how the sheet works out. The flotilla allotment of VSC decals has been released. Only one flotilla in Division 7 has not ordered. Next week the decals will be released to the division designated person (SO-VE). Lauro showed the decals for lost canoes/kayaks. We should encourage owners to put their name and phone number on paddle craft even without stickers. State materials will be in limited supply this year.

Phil Grove, DSO-PV – Excused. Report on file (Attachment C).

<u>Roger Haynes, DSO-PE</u> – Report on file (Attachment C). *Paddle Sports America* is now an authorized PE course. The cost is \$77/10 books. *Suddenly In Command* manuals are also available.

<u>Jerry McAlwee, DSO-PA</u> – Report on file (Attachment C). There will be an NSBW Chairman's meeting at 1730 today. DCDRs, if your NSBW Chairman is not, please attend in their stead.

Dean LaChapelle, DCAPT – SPT called for the following reports:

<u>Irene Wetzel, DSO-CS</u> – Report on file (Attachment C). The web site is for information. Wetzel will be in the lobby tomorrow to do updates if you'd like. There will also be a class on how to use the web site.

<u>COMO Marilyn McBain, DSO-IS</u> – Report on file (Attachment C). McBain has 160 performance awards for this conference which are being distributed to the appropriate DCDR. The 1^{st} , 2^{nd} and 3^{rd} place winners will be awarded at the banquet on Saturday. There is nothing new in IS.

<u>Steve Johnson, DSO-MA</u> – At the PCA Fair, the store sold \$4000+ in merchandise. We are still filling mail-in orders. The store now has the new ODU sew-on insignia, except for FSO which is on back order.

COMO Mike Maddox, DSO-MT – There is training scheduled for this week-end.

<u>George Knies, DSO-PB</u> – Report on file (Attachment C). Knies has been overwhelmed with suggestions and ideas for articles for the *Northwind*. In order to include D-Train photos and information, everything for the April issue will be required by 8 April.

<u>Richard Thomas, DSO-HR</u> – Report on file (Attachment C). NSBW is a good time to recruit new members. Membership is going up some, but not a lot. District awards requirements are different than NACO awards. Division 6 is only division eligible for a NACO award. National is considering getting the new member exam on line.

Perata called for the following staff reports:

<u>Bob Hendry, ASC</u> – Report on file (Attachment C). Sector SF is asking for Auxiliarists to participate in major incident classes in Unified Command Force Tasking. Right now we have no one qualified. We are working with them to put together some on-the-job training, and getting a list of people qualified to have available for commander.

<u>Fran Fisher, DSO-FN</u> – Report on file (Attachment C). We need to finish the final unit audits this year. There are still some flotillas that haven't turned in their year-end financial reports.

Robert Firehock, DSO-LP — We will have two sessions Saturday of the legal/finance workshop. The workshops cover money, - how to get it and how to spend it. There will also be a workshop on mediation as a form of conflict resolution. Mediation is another way to resolve conflicts without going to disciplinary methods.

<u>Randy Parent, DFSO</u> – 1 May is the annual district aviation safety workshop. Everyone is invited. Information about the workshop will be posted next week.

<u>Phil Sanchez, DEP</u> – The Friday Fun Night begins at 1830. Saturday opening ceremonies are at 0730. The D-Train programs have training sessions and locations.

<u>National Survey</u> – The recent survey was part of project for a PhD candidate. Feedback will come back to us in a few months.

<u>Motion to Amend Appendix G of the District Standing Rules</u> – DCO Williams called on Roger Haynes, DSO-PE to describe the proposed amendments and reasons for the proposals.

Motion:

Mary Kirkwood, DCDR-1 moved and Bob Gwaltney, DCDR-3 seconded that Appendix G, Paragraph 10a of the District Standing Rules be amended by striking sub-paragraphs (1), (2) and (3) and inserting the following sub-paragraphs:

- (1) The Flotilla must have reported at least 52 hours of Public Education classes during the award year.
- (2) The Flotilla must have the highest score of all Flotillas considered. This score will be the total of PE hours plus the total of PE graduate points, divided by the Flotilla active membership at the year end.
- (3) PE graduate points for each flotilla will be the sum of its graduates from classes lasting less than 8 classroom hours times 1/15, plus the sum of all its other graduates. The factor of 1/15 is used to approximate the classroom hours for these graduates compared to graduates of other classes.
- (4) Any flotilla receiving this award for its PE program in one year will be ineligible to receive it again during the following two years."

There being no further discussion, the motion was unanimously adopted.

Motion:

Rod Rollins, DCDR-10 moved and Curtis Han, DCDR-5 seconded that Appendix G, Paragraph 9.b. of the District Standing Rules be amended by adding "Instructors with less than 10 combined PE and MT Instructor hours but whose total PE and MT Instructor plus Instructor Aide hours equal or exceed 25 hours will receive a certificate."

There being no further discussion, the motion was unanimously adopted.

Final Comments – DCO Williams reported as follows:

• Elected officer training for 2011 will be held following the November 2010 District Board Meeting. Units are encouraged to hold their elections prior to the November meeting so their newly-elected officers can attend the elected officer training session.

- The District is beginning to look at electronic media for meetings.
- We need to continually remind our membership to make sure uniforms are correct, clean, pressed when they are being worn.
- Kudos to the D-Train committee for the conference they have put together
- RDML Castillo has stated that District 11's primary focus is RBS and inland waters.

- 2. Division 6 has been assigned 115 PATONS for verification this year. This is an increase over last year, where we had a 100% task completion, and includes one aid 20 miles off of Moss Landing.
- 3. 27 February Santa Cruz Harbor Tsunami Patrol Operation Facility 301219 had a scheduled Safety & Training Patrol already on the calendar. Early that morning, a massive earthquake in Chile triggered tsunami warnings throughout the Pacific. Patrol members held a lengthy discussion as to how best the facility and crew could be utilized while maintaining a "GAR Score" in the green. Communication with both the Harbor Patrol and Station Monterey arrived at the conclusion that the facility and crew presence could be utilized to warn the public about the dangers of a tsunami, inform mariners of the impending event, and recommend that spectators stay well back from the water. Furthermore, if any emergencies were to occur, the facility could assist in response. The first surges of the tsunami began at approximately 1245 and continued for the next several hours. Five to six evolutions, each lasting about 15 20 minutes, were experienced. The surge events consisted of a significant outflow of water followed by the incoming surge. The surge was measured approximately 4 ½ ft. at the fuel dock. Fortunately, although it was an amazing event, there were no significant reports of damage
- 4. Current member training being offered by Flotillas 6-7 and 6-10. A two consecutive Saturday February 6 and February 13 offering of the AUXSEA course has been completed. Two consecutive Saturday March 6 and March 13 offering AUXPAT has been completed.
- 5. Flotilla 6-4 will be offering in April both About Boating Safely as a PE course and AUXWEA as a MT course.

Rescue 21: The Rescue 21 system is up and running in Group Humboldt's AOR and several Auxiliary members have sat in on some discussions pertaining to the new system. The Sector Command Staff asked me if I would be interested in taking part in the actual Operations training of R21. I accepted the offer with honor and completed the mandatory 24 hour course and I am now qualified to work in the Command Center when the system gets fully operational. Taking this course helped with the operational side of how things work and how the Auxiliary will be losing many transmitting frequencies. Several meetings in the coming weeks will discuss exactly what frequencies the Auxiliary will be able to transmit on. Final approval of what the communicators can talk on will come from CHIDIRUX. I hope to have some of this resolved by Fleet week.

New Radio Call Signs: I have been in discussion with the National Telecommunications people and we have been discussing the need to change the call sign process. I have developed a very user friendly call sign platform that has been sent to my Communication counterparts not just at National but other DSO-CM. Several conference calls have taken place and ideas have been exchanged and I believe full deployment of the new call signs will be approved by the Chief Director's Office very soon. After the CHIDIRAUX accepts, then it will be sent out to each District Office. The new call signs may be in database form so they will be very easy to control for both Fixed Land and Mobile. More to follow as it becomes available.

Mavericks 2009: The Auxiliary Communications unit took part in the Mavericks surfing competition in the Half Moon Bay area. We transported the Sector Communications van to the Vandenberg AFB Tracking radar station that looked over the surfing area. The Comms trailer had an OS1 and a Command Duty Officer, both from Sector and they both worked the radios. Our job was to take over Comms when they needed a break or wanted to take a look at the competition. The Sector asked me to attend the HOT WASH that took place a few days later and ideas were brought up about how things could work a little differently. I sent a very detailed report to the Sector Command and they have placed what was stated in their after action so that they can use the lessons learned in November of this year.

HOAX MAYDAY CALLER: Sector San Francisco tasked the Communications unit to help assist with direction finding in the Vallejo area. Communication units from D5 were called out to help assist and that assistance paid off. The D/F pointed into the Mare Island area and the new Rescue 21 backed up our findings. Station Vallejo played a pivotal role in helping with finding the person calling. They may have done a better job than they think because the hoaxer has stopped transmitting.

SPECIAL REQUEST FOR DIRECTION FINDING: I received a call from the MLCPACAREA in regards to persons transmitting over the TRACEN's Police frequency. We were given the frequency to D/F and we successfully completed the mission and the results were sent to both the FCC (who we worked with on the case), the Chief of Police at the TRACEN and the MLCPACAREA. This type of call for assistance has never come our way and it was truly an honor to serve and help solve the frequency issue.

<u>A VERY SPECIAL ACKNOWLEDGEMENT</u>: I would like congratulate Mr. Guy Malloy for being accepted into the States COML training program. Mr. Mallory has been instrumental in the Communications department from the H/F side as well as the SHARES side. He has worked with the National Communications team in both standing by for the Haiti earthquake and the Chilean Earthquake. Mr.

Mallory is the Division Staff Officer for Communication in Division 10 and I thank him very much for ALL that he has done and continues to do. BZ to you Mr. Mallory!

New Repeater Equipment: I was advised by the Commodore at the last District meeting that funds for the new repeater will not be available. I have decided to fund this effort myself as I believe that our membership deserves the best in what the Communications Department has to offer. My ADSO-CM for repeaters has been given an amount that he will be allowed to spend out of my own pocket. He has assured me that he will be within the guidelines. As soon as I get the green light, we will be installing the new system with the Sector's blessing.

<u>DTRAIN</u>: The Communications Department has been asked to help out with communications at the event. I will have the Sector Communications trailer on location as well as portable radios with ear buds. The radios will be assigned to those in the red shirts.

<u>Several High Profile Search and Rescue Cases</u>: During the past couple of weeks and months, the ACU's (Auxiliary Communication Units) have been involved in some very significant cases that have turned out positive and some that were less positive. A very special THANK YOU to ALL the Mobile Communicators who not only take the time to come out and dedicate their time to a patrol but also list themselves as being available in the ARMS System. We have some of the best around when it comes to response! The ACU have been acknowledged by the Coast Guard's District and Sector PA Department.

*******The Following is a continual message from the LCDR at Sector San Francisco. The amount of false MAYDAYS is getting way out of hand from all over the District. The violations also come as "Radio Checks (which are illegal) and children playing around on their parent's radio. Clearly the hoax MAYDAY can be disguised as anything! ********

SPECIAL ANNOUNCEMENT FROM SECTOR SAN FRANCISCO:

LCDR Lusk — Sector Command Center Chief has asked ALL members of this Auxiliary (radio operator or not) that have marine radios either in their home or vehicle to listen in whenever possible on VHF CH16. There have been a BIG number of FALSE MAYDAYS that have come in. If the member happens to hear the MAYDAY call the member is requested to call the Sector Command Center at 415-399-3530. The Member can really make a difference because he or she can narrow the search field down dramatically if he or she gives either his or her LAT/LONG or geographic location and how strong he or she heard the transmission.

<u>AUX RADIO NET</u>: All Communications units are encouraged to check in and if nothing else, test their equipment to see if it all works both on the VHF marine channels as well as the repeater frequency. The net is being held at 2000 local time each Monday evening on VHF CH83A. If for some reason CH 83A is occupied then we will switch our VHF Marine remote to transmit on VHF CH 06A. The Sector Command has approved this.

ARMS (Auxiliary Resource Management System: This interactive site is fully controlled by the DSO-CM and the Auxiliary Watch Officers under the direct Supervision of the OTO, DIRAUX and the CDO at Sector SF. This site that has been established contains several Mobile responders that have stated that they want to be a part of the emergency call out process. The old style of utilizing the 11 N/R roster to make call outs has been replaced by this site. This site emails the communicator with his or her availability for the next 24 hours. These members are only viewed by the DSO-CM and Watch Officer to insure the privacy of the person that has signed up. We are always looking to add more communicators so if you are interested please let me know and I will get you online with this process. I cannot promise that you will be called out for the SAR, but I can tell you that your services can and will be utilized should the need arise. This service has provided Sector SF with several comms related incidents from D/F to SAR and everything in between. All SO-CM and FSO-CM are encouraged to pass this information along to their membership. This site is the only one of its kind in the entire Coast Guard Auxiliary.

Some issues have come up in the recent past as to the exact call out process and who controls that

platform. It needs to be noted that the CALL OUT is in direct response to what SECTOR SF wants and therefore they can make advisements as to who they feel can respond to their calls. I strongly encourage all communicators that wish to be called out to be in and active in this system because there is NO OTHER WAY TO GET CALLED OUT. This position is a dispatching port therefore all AWO's have been instructed to utilize the availability list AT ALL TIMES. Bottom line is that if you are not on this list, or you are and not active on the daily list then you will not be activated, period! ALL MOBILES THAT WORK UNDER ORDERS NEED TO BE IN THE SYSTEM.

NOTE FOR LAND MOBILE OPERATORS:

When requesting orders in POMS, please use the drop down box for "Select Station" and select "Land Mobile". This choice is between Sector SF Prevention and Station Rio Vista. Then in the comments section, at the very bottom of the order request page, state which Area, Station or other unit you will be working with and your intentions while on patrol.

It should also be noted that the ADSO-OP/PAC/LM is activating all POMS related Mobile missions. This will help in the reporting of all missions. All SO-CM and FSO-CM should encourage each and every mobile to get involved with some kind of patrol within their own Division to get familiar with their area of responsibility. Currently there is no need for mobiles during the week unless approved by the ADSO-OP/PAC/LM. Most of the patrol work should be directed towards the weekend. Please note that the patrols will be looked at very carefully to assure that vehicles are not over saturating areas listed in POMS. Summer is here and this would be the time to get out there and patrol. Please submit through POMS and notify me in advance of the patrol date so I can activate.

AMERICA'S WATERWAY WATCH

Events and local clubs are to be targeted for the AWW presentation and distribution of materials with at least 2 per quarter. AWW will be represented at the Commissioning of the Watschae, at the COC for ADM Breckenridge and at DTRAIN.

COMMERCIAL FISHING VESSEL SAFETY

It is still unclear whether a commercial season will be supported by the Fishing Council. Fisherman are hesitant about spending money on updating and requalifying equipment because of the lack of funds. If a Salmon season is scheduled then a SAFE CRAB EXAM SURGE will be done dockside a week before the commercial season opens.

UNINSPECTED PASSENGER VESSEL PROGRAM

Implementation began at mid Feb with calls to all those mariner's holding the Coast Guard Operator of Uninspected Passenger Vessel licenses, otherwise known as the "six pack" license, who live within Monterey Bay ,Bodega Bay San Francisco Bay, Delta regions during March.

Many mariners are not using their licenses, do not have vessels or are working for UC Research Institutes or Sailing Schools. Due to the mariner's lifestyle many have relocated to other areas as 38 letters were returned.

Manny Ramirez of the CFVS office held initial UPV training on 17 March at CGI. Four new AUX completed the course and will proceed to complete the PQS and required exams.

DOMESTIC INSPECTIONS, LIFERAFT INSPECTIONS

Contact was made with the Domestic Inspection Chief and the active Auxiliarist in the Department. An

Auxiliarist will be beginning work on the Machinery PQS during the coming week. Liferaft inspections are continuing to be assigned with the ADSO-MS/L notifying qualified Auxiliarists.

FERRY VESSEL AUDIT PROGRAM

The ADSO-MS/FV reports 40 people at the PCA Fair FVA class. 18 new auditors were trained, which brings the total qualified to 68. To date 32 audits have been completed with 8 scheduled for the weekend.

The walkthrough training has raised a lot of interest. During the first week of May the BAYLINK Ferry will host the auditors aboard at the dock. Auditors will take a complete tour with a CG Instructor. Many simple and complex questions will be answered to cover many levels of experience.

Audit Partners have been used to partner an experienced auditor with a newbie

MARINE SAFETY OBSERVATION MISSIONS

This program is slowly developing an increasing cadre of trained personnel. A group from Division 4 received the training two weeks ago. The ADSO-MS OM is working on refining the areas to be driven to eliminate extra miles and to make the observations more efficient. This program is in conjunction with requests from Sector San Francisco.

Two MSOM missions were done by Div 6 and 1 by Div 1 in March.

PACIFIC STRIKE TEAM

There are two Auxiliary watchstanders from Flotilla 14. Their duties include answering phones, routing messages, greeting visitors, screening vendors and contractors, handling some light reports and filing thus freeing up team personnel and the command duty officer for primary responsibilities.

MARINE SAFETY TRAINING RIBBON

In order to have our Marine Safety ADSO's and SO's and other members up to speed on all the Marine Safety information and where to find answers to their questions we are encouraging the earning of the MS Training Ribbon. The courses can be found on the District Website for MS on the Trident page. This page lists all the courses necessary for the Ribbon. All the ICS, Good Mate, Introduction to Marine Safety and the Coast Guard course Initial Introduction to Marine Safety. All the courses are downloadable from the page and the only test that is proctored by the CG is the IIMS.(Initial Introduction) This test is being given at DTRAIN, as well as an hour review of the material before the test. We have fully subscribed the test at 20 members.

REGIONAL EXAM CENTER

The National Maritime Center now handles all Licensing and Documentation. The local REC still does testing, grading, and collection of mariner documents for forwarding to the NMC.

Under development is the Course Audit program. The NMC is reworking the parameters for what the local REC's will do for Course Auditing and the REC will recommend what the Auxiliarists will do. Hopefully, that will come about before many months pass.

COMMERCIAL VESSEL Mission at NATIONAL under development

A new National Commercial Vessel Team is being formed to exp[and training and implementation in this mission area. Director Kester and Deputy Director Murphy are on the development team.

- 1. PLANNING A WINNING ATON/CU PROGRAMS: Was New Orleans Saints becoming the 2010 Super Bowl Champions, just another lucky fluke? Not a chance! Before the necessary teamwork on the field is brought to bear with each team member executing their job with great precision against an opponent, Head Coach and his staff spends hours preparing for each game. Each game plan contains five elements—Study, Planning, Preparation, Training and Execution. As I gloat on this great New Orleans Saints win, it occurs to me that we could learn a great lesson from their management approach in the Navigation Systems ATON/Chart Updating programs.
- 2. The 2010 Coast Guard Light List: The new light list is now available from the Coast Guard Navigation Center web site and all other copies of the light list are now obsolete and should not be used. http://www.navcen.uscg.gov The 2010 Light List Corrected through Coast Guard LNM 52/09 for D11 Coast Guard District just clicking on the map. The publication contains a list of lights, sound signals, buoys, daybeacons, and other aids to navigation. They are in PDF format and are approximately 3.17 MB in size. It is recommended that after downloading to save the files to their hard-drives. Print only the pages you need when you need them.

In order to provide the maritime community with the best possible product, the Coast Guard Navigation Center is offering two alternatives for those who would like the current black and white pages replaced. The new color pages may be downloaded from the Aids to Navigation Insert link below and printed locally for insertion and reference. http://www.navcen.uscg.gov

All SO-NS, FSO-NS Staff Officers, Aid Verifiers, and all operational members should have a copy of this new Coast Guard Light List, Volume 6 on your computer for printing a hard copy for your AOR when needed for referencing aids to navigations within your AOR.

- 3. <u>COAST GUARD DISTRICT 11 LOCAL NOTICE TO MARINERS:</u> All SO-NS, FSO-NS Staff Officers, Aid Verifiers, and all operational members should also be getting a copy of the Local Notice to Mariners via email from U.S. Coast Guard Navigation Center. The LNM has important information about your AOR such and Chart Updates, Light List updates, Bridge work information and GPS information. Sign up to get you weekly copy by just going too: http://www.navcen.uscg.gov.
- 4. LORAN-C TERMINATED: The Coast Guard published a Federal Register notice on Jan. 7, 2010, regarding its intention to terminate transmission of the LORAN-C signal Feb. 8, 2010. In accordance with the DHS Appropriations Act, the U.S. Coast Guard terminated the transmission of all U.S. LORAN-C signals effective 2000Z 08 Feb 2010. At that time, the U.S. LORAN-C signal was permanently discontinued. This termination does not affect U.S. participation in the Russian American or Canadian LORAN-C chains. U.S. participation in these chains will continue in accordance with international agreements. The Canadian Coast Guard has also issued a statement, which is shown on their website. The Coast Guard strongly urges mariners that had used LORAN-C for navigation to shift to a GPS

navigation system and become familiar with its operation as soon as possible. Mariners can't use LORAN-C for navigation as of Feb. 8, 2010. LORAN-C has, as a result of technological advancements in the last 20 years, became an antiquated system no longer required by the armed forces, the transportation sector or the nation's security interests and was used only by a small percentage of the population. The Coast Guard understands that LORAN-C was still used by a small segment of the public and that those users must shift to GPS or other systems. Continued use of limited resources to operate LORAN-C was no longer prudent use of taxpayer funds and is not allowed under the 2010 DHS Appropriation Act. The decision to cease transmission of the LORAN-C signal reflects the president's pledge to eliminate unnecessary federal programs.

- **5. <u>PCA TRAINING</u>**: I conducted two classes at the Past Commanders Association Training Fair on February 20 & 21, 2010 at Coast Guard Island, Alameda, CA.
 - (A). AID VERIFIERS: This qualification course and exam that was held on Saturday. The emphasis on the AV program was on prevention, accuracy, credibility, professionalism and service to the Coast Guard. Our focus in D11 Northern is directed toward building the recognition of each Auxiliary AV-Aid Verifier as a highly competent observer and reporter in the eyes of the Coast Guard. Guidelines for all Aid Verifiers have been established on our 2 web sites District & temporary National at http://ns.d11nuscgaux.info/ns.html and http://www.uscgaan.com. These guidelines include the taking and reporting of fixes and depths, the pre-underway and on-scene evaluation of the electronic equipment being used, high quality on-scene observations, and professional verification report preparation. Fixes are taken with GPS sets using WAAS or DGPS, physical measurements, photographs, and the comparison of all observations to the Light List, the Coast Pilot and to the applicable NOAA Nautical Chart should be included in the verification process.
 - (B). CHART UPDATING: Any Auxiliary Member who would like to update or improve their charting skills can by going to our District and temporary National web sites at http://ns.d11nuscgaux.info/ns.html and http://www.uscgaan.com. The focuses on the Auxiliary Chart Updating program is directed toward raising your competence in the eyes of NOAA-NOS by focusing on prevention, accuracy, credibility, professionalism and service to the NOAA-National Ocean Service. There are specific guidelines for taking fixes and depths that require pre-underway validation of all equipment that is used to perform measurements, and for reporting quality control evidence for each on-scene observation and instrument reading. Also required are explanations of the technique(s) used to acquire any reported data. Observers are directed to define each chart update task, list their on-scene observations, develop a conclusion from the collected evidence and make a final recommendation to NOAA-NOS. A fresh scientific approach is encouraged. Evidence can take the form of a fix taken with a GPS set using WAAS, depths corrected to the charted vertical datum, physical measurements, photographs, drawings, marked up chart and printouts from the Internet. Any official document that supports your contention is great support evidence. The Internet can also supply great supporting data. In effect, you are pleading the case for acceptance of your premise as a chart update to NOAA.
- 6. COAST PILOT 7 42ND EDITION 2010 IS NOW OUT: Coast Pilot 7 covers the coast of California, Oregon and Washington between Mexico to Canada's British Columbia coast. The Coast Pilot supplements the navigational information shown on the nautical charts. As Auxiliarist we are urged to report errors, omissions, or differing conditions to those found in the Coast Pilot, or shown on the charts, in order that they may be fully investigated and corrections made. Auxiliarist should use the NS-CU05 Coast Pilot Text Correction Worksheet or use the Coast Pilot Report form which is included in the back of the Coast Pilot and attached to the NS-CU03 Chart Updating form. These reports shell be sent to

the DSO-NS.

- 9. DATES OF CHART LATEST EDITIONS: D11 Northern Region had 8 New Chart Editions for 2009. We had only 2 New Chart Editions in 2008. See "Dates of Chart Latest Edition Table" for D11 Northern Region which is on page 7. Charts with edition dates prior to those listed in the table are obsolete for use in Navigation, ATON, PATON and Chart Updating activities. The date of a chart is of vital importance to patrol operations, aid verification and chart updating activities. When charted information becomes obsolete, further use of the chart for navigation may be dangerous. Natural and artificial changes, many of them critical, are occurring constantly; and it is important that we in the Auxiliary use the most up-to-date charts and publications. The web address below is an excellent source for charts to attach to your Chart Updating, ATON discrepancy reports & Unpermitted PATON's found because these charts are the most update charts you can get.

AWARD: FOR OUTSTANDING FLOTILLA TROPHY IN OPERATIONS:

It is with sadness that I have to write that again we do not have a flotilla that meets the criteria to receive the above award. Many flotillas should have been able to receive it except for one item. This award is a perpetual trophy with a keeper award and should be given out every year. This is the criteria:

- 1. All operational facilities must be currently inspected
- 2. The flotilla must have the highest number of operational hours
- 3. All Operational personnel in the Flotilla must have maintained the Region's minimum performance standards for the awards year and attended any mandatory workshops for the award year.

Award description is very straightforward. If you have members who are REYR and no longer wish to stay current have them taken out of the category they are in. Once a member has earned the Coxswain Pin, he/she can always wear it, but it hurts the flotilla to show them REYR in AUXDATA. Request DIRAUX to remove them from that qualification in AUXDATA.

BOAT CREW GROUND SCHOOL: We had our first Boat Crew Ground School in ten years during the February PCA Fair. Received high marks on the evaluation form and it appears we will have some

excellent crew personnel in the near future. This class will be offered again, at the PCA Fair, during February 2011.

Coxswains please advise where you see weakness in new crew so we can all direct better training in those needed areas.

QE MEETING ACTIONS: CHANGES IN REPORTING TARGETS W/RELATIVE BEARINGS OR CLOCK POSITIONS Important discussions included the reporting of bearings and securing lines cleats. Operational Updates:

- 1. Reporting of bearings, while underway, is acceptable to be done by relative position or clock hour location whichever is safe and is preferred by the coxswain and preference explained during the pre-brief;
- When securing a line to a standard cleat some references tell us to make a round turn and three
 figure eights others tell us to make a complete turn and three figure eights. On some boats the
 cleats are relatively small and will not accommodate the round turn thus, the complete turn is
 acceptable.
- 3. Weather hitches should not be used during towing evolutions when they are likely to jam and fingers get caught. One method is instead after the figure eights; take several complete turns around the cleat with the bitter end of the line.
- 4. When securing to a dock whatever method is safe and preferred by the Coxswain should be used.

Unsure at this time when we are offering the next ICS-210 class.

OPTREX/OPEX REQUEST DATES: Please verify you have requested alternate dates for your events. The first request with candidates that are ready for a Qualification Examiner will have priority.

REQUALIFICATION DATES: Several members have asked when they are due for on the water requalification. We are on a three year cycle:

LAST CHECK RIDE: 2005 OR 2006 – MEMBER WAS DUE 2009 LAST CHECK RIDE: 2007 – MEMBER IS DUE 2010 LAST CHECK RIDE: 2008 – MEMBER WILL BE DUE 2011 LAST CHECK RIDE: 2009 – MEMBER WILL BE DUE 2012

NAVRULES, for Coxswains and Personal Watercraft Operators is every five years, from the date taken. TCT is every five years and expires December 31 of the fifth year. Verify with your FSO-MT or FSO-IS for your due dates.

In the fall of 2007 I assumed the District Publication Officer's duties, at which time publication of the *Northwind* was transitioned from a printed quarterly publication to an electronic edition. The January 2007 edition of the *Northwind* was the last printed edition (20 pages color and grey scale, 1,450 copies at a cost of \$1,802.90). The last ten electronic issues represent a savings of approximately \$17,000.00.

October 2007 was the first electronic edition comprising 20 pages. Two PDF color versions were published; one for reading on line and our web site, and one hi-def for printing. In addition 25 copies were printed in color for distribution to District Coast Guard Commands and State Boating Waterways and Law Enforcement agencies.

District PE graduates in 2009 were 3,496 youth course grads and 980 adult course grads. Goals for 2010 are 3,500 youth course graduates and 1,100 adult graduates. So far 2010 has 107 graduates recorded and half are ABS. This early in the year our instructors are working on MT (1,450 hours) rather than PE (240 hrs).

I will debut the customized **Suddenly in Command** program at D-TRAIN. It targets the parks' "campfire" 2 hour presentations. The student is the fishing buddy or spouse who accompanies the boater, but with hooks intended to reach the boater when something he/she does not know is touched upon. It promotes the District web site for locating PE and VE opportunities and includes the invitation to join the Auxiliary. I will distribute copies so plan to attend my D-TRAIN Saturday PE workshop before lunch. We still need photos for the "oops" section so please email or bring softcopies this weekend. You are encouraged to localize the materials and the photos when you present the course.

The focus of N'TRAIN for RBS this year was to form a team of RBS members to coordinate our efforts to reach and educate boaters to decrease boating casualties. Please assist them as necessary in completing their qualification. Please make certain that their CURRENT MT-2 form (11-09), CURRENT 7038 (01-08) and CURRENT 7029 (01-10) are filled out correctly. As in the past, the MT-2 form must be signed by their Flotilla Commander prior to being submitted to the DIRAUX office. Any wrong step in the process will unnecessarily delay completing their qualification and receiving credit for VSC activity. Once their initial 5 VSC's are completed, please close your 7038 and start a new one. Otherwise, the trainee will show with as many VSC's as you place on the form with their name on it. One last point from the Director's office, PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS PRIOR to submission of the MT-2 to the Director's office.

NOW is the time to start formulating plans for NSBW, May 22 -28 , followed closely by VSC Mega-Weeks. Please don't wait until the May flotilla meeting to start discussing plans. 

Requests processed since mid-February

Since February 15, approximately 12 formal requests were handled for Auxiliary assistance.

Opportunity for Auxiliarists to be deployed in Incident Commander Centers

I am working with the CDR – Planning to identify Auxiliarists who have the education and training to work in an Incident Command Center both in administrative capacities and also in positions of coordination. Specific ICS are normally required for coordination positions but there may be several opportunities in exercises in which on the job training can be obtained.

The latter may qualify those participating Auxiliarists to work in that capacity when the need may arise. More to come after an identification of candidates has been completed.

Incident Response and Training Plan Update

A visual depiction of the subject plan (distributeded last October) was developed and modified to clarify that elected District officials needed to be in lead positions in the event that the CG requested Auxiliary assistance in a response situation. The visual depiction was distributed to all members of EXCOM for their review and approval. I will be available for its discussion at the March 26 EXCOM meeting as directed.

Marine Safety - Observation Mission Update

Stations Rio Vista and Vallejo are requesting more assistance in this program. I am working with the ADSO-MS for this program to develop a gap analysis of where trained Auxiliarists live versus where the needs are. Such analysis will result in the recruitment of members living in the requested areas, a deployment of some currently patrolling to needed areas as well as a redistribution generally of assigned areas.

Patrol Area Coordinators Coordination Meeting

On May 17, I attended a meeting called by Gail Ramsey, DSO-OP to provide information for coordination purposes with the Patrol Area Coordinators, the CG Sector and Station Auxiliary Liaison personnel and the DSO-CM and DSO-AV. For general information and possible use, it was reported that a CG Boat and a CG Helo was being requested for a planned 5/16 NSBW event at the Berkeley Yacht Club. Also, it was reported that the dates of May 5-7 should be noted for the commissioning of the WAESCHE. At the request of DIRAUX, Simone Adair is the point of contact for land-based AUX activities.

If any Auxiliarists should receive an email of this sort, make no presumptions. Please contact the "sender" Auxiliarist to determine the source - it is most probably not the Auxiliarist. And it goes without saying that Auxiliarists should assure that their computer is protected from this hacking potential.

As a reminder, all Auxiliarists should be aware that personal messages, opinions and such non-Aux related material should not be sent over any Auxiliary or Coast Guard systems. Mis-use of these systems can lead to disciplinary action.
