MINUTES US COAST GUARD AUXILIARY DISTRICT 11NR BOARD AND STAFF MEETING 18 June 2011

Coast Guard Island, Alameda CA

The meeting was called to order at 0935 by DCO Angelo Perata, who introduced the following special guests:

CAPT Cynthia Stowe, Commander Sector San Francisco YN3 Wanda Meyers

The Pledge of Allegiance to the flag and the Coast Guard Ethos were led by Rod Collins, DCOS.

Ralph Bettman, ADSO-SR called the roll, and DCO Perara declared that a quorum was present. The attendance list is attached to these minutes as Attachment 1.

APPROVAL OF MINUTES:

DCO Perara called for approval of the 25 March 2011, 20 April 2011 and 18 May 2011 minutes. There being no discussion, the minutes were unanimously approved, as distributed.

REPORT – DCO ANGELO PERATA – DCO Perata reported on the following items:

- As of 10 June 2011, our District membership was 1536 members, and 372 retired. We had
 contributed 50,000 hours. We have 190 Crew and 136 Coxswains who have provided ____ assists
 with 21 saved. We have 153 total facilities with 145 active.
- The US Coast Guard Association will receive \$25,000 from Chase Community Giving campaign. It finished in the top 10 charities.
- A Strategic Plan is being prepared for 2012 through 2016.
- Boating accidents in our District were down, except for paddle sports where there were 135
 fatalities last year, which is up from the previous year. There are 11 specific plans to improve
 this year (i.e. Lifejacket wear,). The Army Corps of Engineers has a mandatory requirement for
 PFD's on boats on their lakes.
- There is a new ALCOAST regarding uniforms that has been sent to all hands.
- DCO Perata is working on inland lakes charts with area grids. DCO Perata showed a copy of a chart with grids, indicating that they cost about \$3.00 each to print and cover. This charting has been done in Utah with approval from the Department of Natural Resources. On the back of the chart is useful information on facilities patrolling the lake and how to do a SAR. CAPT Stowe indicated her support for the idea

DISTRICT BOARD REPORTS:

DCO Perata directed Rod Collins, DCOS to call for district board reports as follows:

<u>Simone Adair, DCDR-1</u> – Report on file (Attachment B). The division provided a patrol for paddle boarders at Station. They are implementing Everbridge. Plans are beginning for Fleet Week and the 100th Anniversary of naval aviation. Patrols were provided on Opening Day. Division members visited the SSF water treatment plant and provided volunteers for the Presidio Cemetery on Memorial Day.

<u>Edward Kief, DCDR-3</u> – Report on file (Attachment B). They are working to get their Standing Rules updated. The DSO-LP has a copy for approval.

<u>Joaquin Duran, DCDR-4</u> – Report on file (Attachment B). Opening day on the South Bay was very successful, as were the division's NSBW activities. They are processing seven new members.

<u>Curtis Han, DCDR-5</u> – Report on file (Attachment B). The division held a Lake Berryessa cruise with dinner at the station. They have been active at Lake Berryessa with 10 patrols last month, 12 vessel assists, and 5 rescues. They have also been active at Lake Sonoma.

<u>Wallace Smith, DCDR-6</u> – Report on file (Attachment B). There were many NSBW activities. 25 members of the public attended a CPR class supported by Station Monterey. LT Cooper is the new CO at Station Monterey.

<u>Lou Carroll, DCDR-7</u> – Report on file (Attachment B). The Division currently has access to 5 state boats for use. There was an OPTREX 10-11 June with two QEs were in attendance.

<u>Bruce Rogerson, DCDR-8</u> – Report on file (Attachment B). \$70,000 was received to assist fisherman to recover from the Crescent City tsunami. Flotilla 8-7 transported a navigation aid for the CG.

<u>Denis Eaton, DCDR-10</u> – Report on file (Attachment B). Travel is an issue for this division. Training for crew is at a critical mass with 2 coxswains and 2 boats. Having the store with materials is very successful.

<u>Leon Borden, DCDR-11</u> – Report on file (Attachment B). We have a watchstander at the station. Nevada has a mussel issue. In order to launch a boat, people need a seal from the inspection station at a cost of \$60 to \$240. The Auxiliary pays \$35 to \$40 for inspection the inspection.

<u>Nick Tarlson, DCDR-12</u> – Report on file (Attachment B). We had a full array of NSBW activities. Four guests from the District helped with treats. It was very much appreciated.

<u>Judy Esteban, P-PCA</u> – Report on file (Attachment B). Regarding the memorial, we should have a mock up. We hope to have sign-off in two weeks. We have started construction on the patio per the Admiral's suggestion. Collins added that PCA has committed labor to get the job done.

<u>CWO2 Danny Kilburger, OTO</u> – The Auxiliary Manual was ready to be signed, but CHDIRAUX raised some issues about National Leadership. When those issues are resolved, the Auxiliary Manual will be issued. He has visited several places in our AOR. CWO Kilburger reminded us that, as Auxiliary, we are prohibited from law enforcement activities, but we can transport law enforcement personnel.

<u>Jerry McAlwee, DSO-PA</u> – McAlwee reported on the availability of *Coastie*. He needs reports on PA activities, please submit them this next week.

Roger Haynes, DSO-PE - Haynes recognized Mike Doyle for contributions to the PE program.

<u>Phillip Grove, DSO-PV</u> – Excused. Report on file (Attachment C).

Michael Lauro, DSO-VE – Excused. Report on file (Attachment C).

Kirkwood reported that Mike Lauro DSO-VE reported on the Delta blitz, all boats were filled. Kirkwood went to Division 6 for activities there and mentioned the importance of Aux involvement with their communities.

Dean LaChapelle, DCAPT-RES called for the following staff reports:

<u>Larry Olsen, DSO-AV</u> – Report on file (Attachment C). We make 4 to 5 flights per week and have made several public appearances in our AOR. A new thing; we do have authorization to go to inland lakes where we can give air support. On 9 June we had a sector meeting to review ways we can support.

Jeff Price, DSO-CM – Report on file (Attachment C). Nothing further to report.

<u>COMO Gail Ramsey, DSO-OP</u> – Report on file (Attachment C). COMO Ramsey requested information for the published Ops report. QE qualification candidates need to be fully ready for QE (i.e. have completed 8 hour TCT training). There should be only one point of contact for QE requests.

LaChapelle reviewed the OPTREX to be held 16 July. He reviewed uniform issues (ODUs with boots shoreside, approved boating shoes on the water). This will be a cold water boot camp, and he referred the assembled group to the coldwater DVD and suggested everyone read about cold water survival.

Richard Thomas, DCAPT-SPT called for the following reports:

<u>Irene Wetzel, DSO-CS</u> – Report on file (Attachment C). Wetzel was given a standing ovation of appreciation for the web site. She thanked those who supported the web site.

Bob Davison, DSO-HR - Report on file (Attachment C). Nothing further to report.

Dave Talton, DSO-MA – Report on file (Attachment C). Nothing further to report.

<u>Wesley Craig, DSO-PB</u> – Report on file (Attachment C). Nothing further to report.

Thomas reported that Sacramento County had issued a proclamation of support for the Auxiliary. He also handed out cards for the Tuesday Night Live program to Board members for their distribution. COMO Maddox is working on a program for training elected officers.

Collins called for the following staff reports:

Bob Hendry, ASC - Excused. Report on file (Attachment C).

<u>Steven Perez, DSO-DV</u> – We need to wait for the Auxiliary version of the mandatory diversity program. It is being promulgated by a separate department, not Human Resources. It will be up on the national website in the next 50 days. Perez plans to give up the DSO-DV job and seeks a successor.

Frances Fisher, DSO-FN – Report on file (Attachment C). Next month is the magic month for budget.

Joanna Nevesny, DSO-LP - Nothing to report.

<u>Joyce Bell, DSO-SR</u> – Excused. Nothing to report.

Neil Nevesny, CRC – Nothing to report.

OLD BUSINESS

<u>District OPEX</u> – Dean LaChapelle DCAPT-RES reviewed plans for the District OPEX 16 July as follows:

- Meet in Pt. Welcome room, Coast Guard Island at 0800.
- Classes should begin at 0830.
- There will be 5 classes followed by 9 separate exercises on the estuary, beginning about 0900, covering basic skills (i.e. tying to a cleat, etc).
- There will be people on boats taking notes on goods and improvements for later review and briefing
- At 1630 Hamburgers and hot dogs will be served.
- Once on the water, people will be there all day; bring your own lunch.
- DCO Perata interjected that this is the first time we have done this; we want to make it easy to do it.

<u>AuxChef</u> – Rich Thomas DCAPT-SUP reported on the AuxChef program as follows:

- The program is going well.
- It started in October and November, moving on in March.
- CAPT Stowe has been a big supporter of the group.
- There are 5 instructors in the District.
- YBI had a class during the tsunami alert and helped with the 24 hour alert. They cooked for 70 people.
- This is a good tool for Aux to help the CG.

<u>America's Cup</u> – COMO Vic Connell reported on the plans for the Americas Cup races. The Aux role is not clear, Yacht clubs will provide volunteers. This will be a much sustained event covering 7 to 13 days. CAPT Stowe indicated that CG plans are developing. The volunteer marshal's role is being developed.

Recess: 1130 Reconvene: 1215

<u>Tsunami Assistance Update</u> – DCO Perata provided an update on Auxiliary assistance during the tsunami. Wally Smith DCDR-6 reported 400 volunteer hours during that event. DCO Perata indicated his

intent to report on the event at NACON and read his report draft. ICS worked well, and training was very important. He cited key people as Wally Smith, Becky Barwell and Jeff Price, and offered congratulations to them.

NEW BUSINESS

<u>Everbridge and AIMS System</u> – Dave Talton reviewed Everbridge as follows:

- Because it is an emergency notification system it is to be used for emergencies only.
- AUXDATA is the source of the info used by the system, therefore AUXDATA must be accurate.
- The system can be used for polling, wellness checks, etc. Protocol is that it is used for emergencies only.
- Bob Hendry, ASC, will be the project manager.
- EXCOM has message capability, i.e., Division Commanders transmit to flotillas that, in turn, transmit to their members. The District is the filter.
- Messages will be sent until someone responds.
- Polling is available to determine deployment availability.
- There is a quota message---the system will cut itself off once a quota of volunteers available is reached.
- The system will then provide information reports.
- Talton hopes to have all aboard in July with the first message sent out in August.
- The system does not eliminate the need for phone trees.
- The gold side is not on the AIMS system, but they can benefit from it.

<u>Inland Lakes and Charts</u> – Previously covered in DCO's report.

Nominations for District Captain – DCO Perata reviewed the nomination procedure as follows:

- Nominees must be past Division Commanders.
- Anyone wishing to be nominated should submit their names to the Nominating Committee thirty days prior to elections. Three persons already have done so.
- Elections will be 10 September 2011.
- Incumbent Board members, only, can self-nominate.

FINAL COMMENTS

COMO Gail Ramsey - read a message from Mike Lauro, DSO-VE indicating that his team had provided 100 VSCs on one day. She also requested that we obtain a letter from each disenrollee with a copy to HR.

COMO Vic Connell – asked that we get PPE equipment back or returned to their unit from all disenrollees and that we verify disenrollment. COMO Connell also pointed out that Port Supply is the wholesale distributor of West Marine. We should share the account number with members for a discount of 15 to 45%. If we don't use it we will lose it.

ADJOURNMENT

There being no further business, the meeting was adjourned at 1313.

NEXT MEETING

The next scheduled meeting of the District Board is a Webinar meeting on Wednesday, 17 August 2011. The next on-site meeting of the District Board and Staff will be on Saturday, 10 September 2011 at Coast Guard Island.

Details:

- I was invited to attend a DBW press conference 0900 25 May, 2011 on the Sacramento River downtown Sacramento. The Coast Guard had two PA officers present, several L.E. Agency's, Power Squadron and DART. DBW pushing the "Just Wear It" program and they had a PFD Exchange available, but the weather was cold and wet and very few people took advantage of the exchange. There were three TV stations present and DART partnered with the Sac. County Sheriff's Dept. to give an in the water rescue demonstration for the reporters and the public.
- I wasn't asked to speak, but I had an article from "On Scene Magazine" with me and I approached DBW acting Director Lucia Becerra and talked about the article "when drowning doesn't look like a drowning." During the discussion I asked the Chief Warrant Officer if the information in the article agreed with his experience and he agreed wholeheartedly.
- I asked Lucia if she would consider incorporating the description of a real drowning into their boating safety material and gave her the magazine article. I also told her Flotilla 33 would be teaching this material in our PE classes. The seed has been sown, we shall see.
- Bob Hendry has me registered into Everbridge and we had our indoctrination chat. He will set
 up the flotillas when I learn who will be the new Flotilla Commander for Flotilla 31. I believe Phil
 Barnett is going to resign at the flotilla meeting the 13th and I will be at the meeting. Phil has
 stage four cancer and the treatments are not working as well as hoped for.
- June 4 VE blitz, FL- 33, 35 and 39 had VE stations at three different lakes, but the weather was so bad that there were not many boaters braving the elements.

DISTRICT STAFF REPORTS DISTRICT 11NR BOARD AND STAFF MEETING 18 June 2011

Larry Olsen, DSO-AV

We normally fly about four patrols per week, however, the rain and weather conditions this past winter has reduced our flights to about two per week. With the dry weather coming along, we are now able to schedule and complete more flights.

WORKING WITH AUX VESSELS: We are regularly working with aux vessels in the Delta, conducting both training exercises and actual assists.

RESUME FLIGHTS TO ECHO SECTOR: The Air Station has authorized aux air flights to Lake Tahoe and the other lakes in Echo Sector when we have specific requests and missions.

CLOSER WORKING RELATIONSHIPS WITH COAST GUARD UNITS: Thanks to our Air Station AUXLO, LT Ian Groom, we spent the entire day on Thursday, 09 June 2011, meeting with various Coast Guard units at Sector in order to explore additional ways that aux air can provide assistance. We met with the Enforcement Division, the Marine Safety Division, the Aids to Navigation Team, and the Command Center. As a result of these meetings we are jointly developing operational procedures for aux air to assist with general SAR cases and First Light Responses; as well as with NAVAIDS, Maritime Safety and PWCS; along with Pollution and MEP ops. We also expect to increase the number of fam flights for the operational units at Sector and for the several Stations around the Bay and Delta.

SAFETY WORKSHOP, 30 APRIL 2011: We had a successful safety workshop on April 30th at Coast Guard Island.

PUBLIC APPEARANCES AND AUX EVENTS: We are participating in various public appearances with our aux helicopter and other aircraft. We will be participating in upcoming OPTREX exercises and other events.

During the past few months, there has been a conscious effort to get the correct word out about certain line items like Rescue 21. Some damaging information went out regarding this new radio system and from D-TRAIN to present; we have been working diligently to make sure that our members get the most up to date information. In May, ADSO-CM Kevin Sellstrom facilitated getting the Sector Command Center Supervisor, OSCS Doug Samp to come out and give a discussion about the Rescue 21 system at the Division 3 monthly meeting. Also in May, I attended the Division 4 monthly meeting and gave a power point presentation about the Rescue 21 system, all with the approval from the Sector Command Center. I have scheduled another Division meeting for July and will provide all the needed information to the agreed Division at that time.

LCDR LUSK'S DEPARTURE:

Lieutenant Commander Leanne Lusk has worked tirelessly for the Auxiliary and especially with the Communications. Having her in the driver seat has been a true experience and it is with great sadness that I advise that she is moving on to Washington D.C. to take over the writing of SAR policy. LCDR Don Montoro has begun as the Command Center Chief and the same level of dedication to our program will remain in place. A week ago, I had the honor of attending her departure party and she assured all who were in attendance that she would be back!

NEW IOC AND SPACE IN THE IOC FOR THE AWO:

As some of you may know, the Sector has a brand new Command Center at YBI. Inside this very modern IOC (Interagency Operations Center) will be a space for our on duty Watch Officers. This space will have an Ethernet line so that the AWO can plug right in or go wireless on the Sector's wireless router. The Command Center Supervisor authorized the Aux. Watch Officer to have their own locker that will have all related ICS forms, the updated ARMS roster and anything else that the AWO will need to make sure that if there is an emergency, we are all covered on the Comms side. If the bridge goes out then the AWO can make it YBI by boat if needed. There will be a ribbon cutting ceremony at the end of the month and those people that have been invited know who you are.

POMS information for Land Mobiles:

When placing orders in POMS, please make sure that you have listed ALL LAND MOBILE PATROLS. This is important for recording the numbers for District awards and recognition. Also, during a mobile patrol the only thing that can be reimbursed is mileage not things like ICE or FUEL. Please note that ANY 5132's that are turned in that have things other than mileage will be returned to the member thus making your reimbursement take a little longer.

There will be no more same day patrols. I have been getting emails from communicators that they have had a last minute change in their plans and would like to be activated. It is the responsibility of the member to make sure that his or her calendar is in order. The surface assets require a week's advance notice. I will not go that far, but I would appreciate having all orders in POMS by the Wednesday prior to the patrol.

SAR CALL OUTS fall into a completely different category and orders for call outs will be entered at the time of the call out.

HOAXER AWARD:

Well, it has taken a couple of years but the Communicators that were involved with the silencing of the Hoax Mayday caller in Salinas were recognized at Sector San Francisco's All Hands Meeting that took place on the 31st of May. We were honored to have DCO Perata at the meeting! Captain Jewess had nothing but great things to say about the Auxiliary Communications team and all we do to make their jobs easier each and every day.

OPERATIONS RIBBON RECOGNIZED - TCO-PQS:

CHDIRAUX has announced that "Effective immediately Section 11.A.14a. of the Auxiliary Manual is amended as follows and will be so included in the next update:"

"This ribbon recognizes qualifications in the various operations program areas. Auxiliarists who qualify as an Auxiliary boat or air crew member, air observer, AtoN verifier, Coast Guard watch stander, Coast Guard boat crewman, Coast Guard boat engineer, or Auxiliary interpreter (Level A) may wear the Operations Program ribbon. Watch standers and boat engineers are defined as Auxiliarists who have

been designated in writing by a Coast Guard unit, or the Director, as qualified in that position. Auxiliarists designated by the Director as Auxiliary watch standers according to District requirements may also wear the Operations Program ribbon. Additionally, Auxiliarists holding the Auxiliary Telecommunications Operator (TCO) qualification or who have qualified as AUXCOM prior to August 1, 2008, are authorized to wear the Operations Program ribbon. Auxiliarists show multiple qualifications by adding 3/16-inch bronze or silver stars. The "E" device is authorized to be worn on the Auxiliary Operations Program ribbon by Auxiliarists who are currently appointed, or have been appointed, as a Qualification Examiner (QE) or Flight Examiner (FE). No miniature "E" device for miniature medals is authorized."

SOUTHBAY OPENING DAY:

A very special thank you goes out to the Division Commander from Division 4. The Division Commander contacted me to see if I would be available to take the comms watch for the South Bay Opening Day on the Bay in Redwood City. I accepted the invitation without reservation, made contact with the Division OPS Officer and got all the information needed to make sure that the mission went off as a success. At the brief, I was given the opportunity to have a Reservist go with me and get a first hand view as to how the Comms roll out happens. I worked with both the Sector and Station San Francisco in order to facilitate the proper ICS-205 format and with their assistance was able to come up with an excellent frequency platform. The event went off perfectly.

STATION RIO VISTA - OPTREX or COPEX!!!

Prior to 04MAY2011, I was contacted by the BMCS at Station Rio Vista as well as the Division 3 Operations Officer in hopes that the Auxiliary would be able to provide communications for their exercise. Kevin and Fred Sellstrom (Both ADSO-CM) were also in the loop with this and offered the Comms Trailer for the event. The trailer was used for the ICP and the extremely positive feedback regarding their performance was very welcomed. They did an OUTSTANDING JOB with maintaining a level of professionalism that should be a platform for this Auxiliary. BRAVO ZULU to both of these fine men!

ARMS (Auxiliary Resource Management System)

The ARMS program still exists in this District and still remains the only way to be called out for any Sector related mission. Entry into this system is very simple, just be a mobile communicator (passing AUXCOM or TCO-PQS) and be willing to be available 24 hours a day for any type of assistance that is needed. This could range from helping with securing open microphones to other Government agency liaison work. The Delta region has been stood up as well as the long standing Bay Area. Please contact the DSO-CM to be involved. We currently have 65 members listed in the system. This system also has the ability to text and send out real time emergency information.

CONTINUED REQUESTS FOR AUX COMMUNICATIONS:

Repeater to help them while updates to the R21 system get made. This requires that the repeater be placed on full remote base transmit. 

As previously reported the new online District Store website is proving to be a success. We are still working on the site making improvements and adding items. Currently about a third of the sales are coming from outside the District.

To give a comparison:

In 2008 the total sales for the year amounted to \$12,046. This was prior to our acceptance of credit cards. The total from 1 Jan to 31 May was \$6989.

In 2009 the total sales for the year amounted to \$21,732. This was after our acceptance of credit cards and my adding new items like the Weems and Plath line. The total from 1 Jan to 31 May was \$13,318.

In 2010 the total sales for the year amounted to \$11,236. The total from 1 Jan to 31 May was \$7,811.

Currently we have sales from 1 JAN to 31 MAY totaling \$11,954. Nearly, \$2,400 of that occurred in April and May through the online store. DTRAIN this year only brought in approximately two-thirds of the 2009 DTRAIN numbers which accounts for the lower YTD totals this year compared to 2009.

I have new products coming in that will open a new category for us — "Maintenance and Repair". These are highly rated products that will offer discounted boat maintenance supplies to the Auxiliary. More items will be added as I negotiate with vendors who have proven products that will aid Auxiliary members in the function of our duties.

AGENCY CONTACTS

The DSO-Prevention attended the NORTHERN CALIFORNIA COASTAL & SF BAY/DELTA AREA COMMITTEE MEETING. This Committee is required by FWPCA so that those that are assigned to work in the Pollution, Wildlife, CG COTP and Planners of Industry Exercises and Drills meet to set out concerns, subcommittees are formed to study the problem and a solution proposed. The one important concern just concluded successfully was how to use civilian volunteers in case of a pollution incident such as the *Cosco Busan*.

INCIDENT MANAGEMENT DIVISION AND NEW AUX PI'S

1. WHAT IS THE COAST PILOT? HOW & WHY IS THE COAST PILOT USED? The United States Coast Pilot is published by the National Ocean Service (NOS), National Oceanic and Atmospheric Administration (NOAA). The Coast Pilot supplements the navigational information shown on NOAA nautical charts. All the needed information that a mariner may need for a safe transit can't be placed on charts. This

additional information will be found in the Coast Pilot. The Coast Pilot is continually updated and maintained from inspections conducted by NOAA survey vessels and field parties, corrections published in USCG Local Notices to Mariners, information from USCG & CG Auxiliary, other Federal agencies, State and local governments, maritime and pilots' associations, port authorities, and concerned mariners. In the Eleventh Coast Guard District we are using **Coast Pilot 7 - 43ed Edition, 2011** which covers the rugged United States coast of California, Oregon and Washington, between Mexico on the south and Canada's British Columbia on the north. Coast Pilot 7 also includes Hawaii and other United States territories in the South Pacific.

You can and should download only the **Coast Pilot 7 - 43ed Edition, 2011** chapters that you want or need. I recommend, depending on your AOR, the following chapters (if you don't want the complete book) for all Coxswains, Aid Verifiers, Chart Updating members and all northern region boating Auxiliarist (Front Page, Chapters 1, 2, 3, 6, 7, 8 & Appendix A and B.)

The Coast Pilot is part of our Chart Updating program. Check out how to make changes or correction to the Coast Pilot at our D11NR Navigation Systems web page at. http://ns.d11nuscgaux.info/ns.html If you have any question on how to make a Coast Pilot changes or correction please contact James B. Bridge Survey Report: Submitted by AVs using the D11 Bridge Survey Report with associated bridge activity being reported to **AUXDATA** as **Mission 32**. Your Bridge Survey can report a bridge as either watching properly or as a discrepancy.

ATON (Federal Aid) Discrepancy Report: Submitted by AVs using a **NS-AN04 Aid to Navigation Report** and forwarded to the DSO-NS for distribution to proper Coast Guard Unit with associated bridge activity being reported to **AUXDATA as Mission 30**. Note that reports for ATONs (Federal Aids) observed as watching properly should never be reported to the Coast Guard. The only exception is when the Coast Guard specifically directs you to check or photographing Federal Aid. Credit then should be taken in AUXDATA for these checks.

Aid Verifiers who have been working directly in support of CG ANTs in 2010 who have no reported activity will not be placed in REYR. However, all AVs are always encouraged to record any ATON, PATON and Bridge Activity on ANSC 7030 and forwarded to your FSO-IS Officer. Always advise your DSO-NS of this activity.

Passing the 5-Year Aid Verifier Open Book Re-certification Exam. Taken & passing with a score of 95% will certify your for 2011. All Aid Verifiers must take the 5-Year Aid Verifier Open Book Re-certification Exam ever 5 years to maintain their Aid Verifier Certification.

5. FREE UPDATED NOAA RASTER AND VECTOR NAVIGATIONAL CHARTS FOR YOUR GPS CHARTING PROGRAMS: Do you need to update your GPS Navigational Program Charts? I have a possible alternative to paying the high cost to for chart CD's. You can download Free NOAA Raster Navigational Charts and: Vector Navigational Charts for NOAA-Nation Ocean Service. NOAA-NOS are now offering Free NOAA Raster Navigational Charts: NOAA-RNCs and Electronical Navigational Charts: NOAA-ECNs through the NOAA's web site at http://www.nauticalcharts.noaa.gov/staff/chartspubs.html. I'm using them on my navigational charting programs on my laptop and home computers. It is working great for planning and navigating. Log on and look under "Nautical Charts & Products" and click on Raster Navigational Charts: NOAA RNC or for vector charts Electronical Navigational Chart: NOAA ENC and follow the instruction.

First Repeater 2011 Up to Date Light List: Do you have the most update copy of the 2011 Light List? Ever operational facility, Aid Verifier and member with a boat should have the most up to date copy of the Light List. The electronic version of the Light List is updated monthly, by the first Friday of each month, and is available on the USCG NAVCEN website at http://www.navcen.uscg.gov/.

LESSONS LEARNED – Contributed by David Naumann

A disclaimer: No Auxiliary members were directly involved with medical aid to the injured party.

Saturday 28MAY at approximately I300hrs I received a request from the Sheriff's Patrol boat to respond to a boat that was DIW. My crew and I located the DIW boat, took it under tow and proceeded to the launch ramp located about the middle of the lake (North to south). As we neared the dock/launch ramp area Santa Clara Fire and an AMR paramedic unit were arriving on scene. A boat already docked had an injured party aboard. The victim had lost portions of 2 fingers and seriously injured a 3rd. AMR paramedics treated the injured. I assisted the Park Ranger in searching the boat for the missing fingers. (None were found. It is assumed that they went overboard.) We had spoken with the occupants of the boat earlier. It was the first time the driver had been out in the boat. I suggested that a Boating Safety Class would be appropriate. They agreed. Per the occupants of the boat, at about 1300 hrs, when towing an inflatable the driver throttled up before taking slack out of the tow line. The victim, seeing the slack grabbed the tow line in an attempt to cushion the shock to the tow toy. Unfortunately his fingers were caught in a loop of the tow line, severing parts of 2 fingers and severely damaging a third. A vivid lesson in keeping fingers away from lines and cleats.

REIMBURSEMENT FOR PATROLS FROM FINANCE:

The subject has been asked again how to get reimbursed from finance for patrols. We can only be reimbursed by direct deposit from the Finance Center (FINCEN). The link below goes to the form that needs to be filled out. Please make certain every Facility owner and Coxswain has the necessary information on file. Be certain to include your checking account information. https://www.fincen.uscg.mil/secure/enrollment_form.htm

UNIFORMS FOR OPERATIONS:

According to the Operations Policy Manual we should wear:

- The appropriate uniform authorized in the *Auxiliary Manual*, COMDTINST M16790.1 (series), or OPORDERs (as authorized in *paragraph F.7* of *Chapter 1*). The OIA may, for emergency call-outs only, waive the requirement for being in appropriate uniform and displaying patrol boards. This does not apply to PPE.
- Hypothermia protective suits, when required.
- Appropriate PFD with required survival equipment attached.
- The same uniform (normally) for all crew

OPS POLO SHIRT: From the National WEB Site "Knowledge Base"

The operational polo was designed to be worn with the ODU long trousers but can also be worn with the hot weather uniform, correct?

The answer is in ALAUX 014/05 and will be incorporated into the next edition of the Auxiliary Manual. The message clearly states the dark blue operations polo shirt "is an alternative to the Coast Guard

Working Blue Uniform shirt and the Operational Dress Uniform (ODU) shirt, including cases when worn as a hot weather outfit". Check with your OIA that this alternative is authorized in your region and doesn't conflict with local uniform requirements.

I could go further into what we can and cannot wear but will wait for the "NEW" AUX Manual to come out so we can all be surprised, ... or not.

WEST MARINE BENEFIT FOR AUX MEMBERS (Great Info Supplied by Linda Vetter):

This is to publicize another benefit of Auxiliary membership, especially for those of you that have boats or like to shop for nautical clothes or gifts. Members can utilize a Port Supply (basically the commercial arm affiliated with West Marine Stores) account number to get discounted prices on merchandise at all West Marine stores. This should mean that you will pay less than the listed store price on most anything they offer, a nice benefit.

A single Port Supply discount account number (# 455374) has been set up nationally for USCG Auxiliary member usage. (Port Supply used to issue individual accounts by flotilla, division, or districts, but discontinued that a few years ago. One problem was not all flotillas/divisions had them or wanted to be bothered, and members from elsewhere would get added to other's accounts, plus lots of accounts for Port Supply to deal with. There are still some out there in use as they were "grandfathered" in, but now they no longer issue those and want all under just one account). Port Supply is happy to provide this service and discounts to all Auxiliary members for their use across the board.

The account is good for usage in any West Marine or Port Supply retail outlet (including special orders, so presumably for anything they offer), but NOT for "over the phone" or internet orders. The main reason for that is so that they know it's being used by an Auxiliarist (*requires an Auxiliary ID card check*). Merchandise can be purchased by cash, credit card, or COD. It cannot be used in conjunction with other discount accounts or rebate system cards (e.g., you cannot get points on a West Advantage or Boat US card account at the same time as using the Port Supply account discount, so please don't ask).

The account can be used by any currently valid Auxiliary member. The store clerk should request to see a valid Aux. ID Card, as the main way to ensure it is a valid Auxiliary member using it, so be sure to have your current (non-expired) ID card available (uniforms are not required). They also need a number to enter as the PO (purchase order) number, and may ask for your District/Division/Flotilla number (the "11Nddff" type number) for the PO number, so be prepared to give them that as well. So write down the number (Port Supply account # 455374) and use it for future procurements at West Marine and enjoy.




